I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that Bisawarup Haldar, S/O- Bipadbaran Haldar of Vill- Joypur, P.S- Joypur, Dist- Purulia has used his existing electric connection for the purpose other than the purpose for which the service connection was actually provided which comes U/S 135 1(e) of electricity act 2003 subsequently amendment act 2007.

On 01.12.2023 at about 01.20 P.M. I, Sri Rabindranath Das S/O- Sri Murari Mohan Das, AE & Station Manager, Joypur CCC along with 01. Abhishek Singh, DE(E), Purulia Region Office, 02. Vikram Singh, JE(E) Gr-I, 03. Raushan Kumar, JE(E) Gr-II, Joypur CCC and 04. Sristidhar Mahato, HG TSH, Joypur CCC entered the premises of Bisawarup Haldar, S/O- Bipadbaran Haldar of Vill- Joypur, P.S- Joypur, Dist- Purulia and found that Bisawarup Haldar supplied electricity unauthorizedly from his existing meter (No. L3531765, Con ID: 201082494) to another premises of deemed disconnected connections of 01. Bansi Badan Halder having Consumer ID: 242058133 and 02. Bamdeb Haldar having Consumer ID: 242203745 with outstanding dues and total connected load found 1.89 kW. The connection is disconnected on date with Final Reading 10444 kWh. As Bisawarup Haldar, S/O- Bipadbaran Haldar committed an offence U/S 135 1(e) Electricity Act, 2003(Amendment Act, 2007), I seized the following articles after preparing the seizure list in presence of 01. Raushan Kumar, JE(E) Gr-II, Joypur CCC and 02. Sristidhar Mahato, HG TSH, Joypur CCC. The inspection team left the premises at 01.40 P.M.
