There after the accused persons fled away and at that point of time they snatch my golden chain, I along with my son Mukesh Mahato were treated as Joypur Hospital. I was totally out mind for that situation I could not file complain within time .

2. There after I reported the matter was brought to the O/C. Joypur Police station and the Police officer assured me that appropriate legal action would be taken against them but unfortunately till today no action or no any specific case has yet been started against the accused person and the accused persons still thereatning in various way .

3. That there after the complainant went to police of joypur P.S. and requested them for an enquiry and also requested them to make arrangement but Police of Joypur P.S. denying to accept her complaint but to ask the complainant to the Ld. Court for filling complaint .

4. That the Accused Persons Committed various offences Punishible under the Indian Penal Code inelvdng section .

5. That the Matter was reported to the officer in- Charge Joypur P.S. against the accused persons but the said officer -in- Charge didnot taken any legal action then the complainant lodge another complainant to the Superintendent of Police, Purulia but with same fate them the complainant under Compelling circumstances is filling this complaint
