On 05.12.2023 at about 01.30 P.M I, Sri Rabindranath Das, AE & Station Manager, Joypur CCC along with 01.Raushan Kumar, JE(E) Gr-II, Joypur CCC ,02.Ganesh Mahato, Gr-I TSH, Joypur CCC entered the premises of Balaram Mahato, S/O-Lt. Bibhuti Mahato of Vill- Kawahara, P.S- Joypur, Dist- Purulia and found that Balaram Mahato, S/O-Lt. Bibhuti Mahato was enjoying electricity unauthorizedly tapping from the incoming service line of WBSEDCL by means meter bypassing to his domestic premises and connected load found 0.59 KVA. As that Balaram Mahato, S/O-Lt. Bibhuti Mahato committed theft of electric power. No article has been seized. Only connection has been disconnected from the circuit. The inspection team left the premises at 01.50 P.M.

Balaram Mahato, S/O-Lt. Bibhuti Mahato of Vill- Kawahara,, P.S- Joypur , Dist- Purulia has committed an offence U/S 135(i) (b) Electricity Act, 2003(Amendment Act, 2007), so you are requested to take cognizance of this complaint and treat it as F.I.R.
