Sir,

In producing here with arrested accused persons namely (1) Binod Bagti (39 yrs) S/o-Banku Bagti (2) Lakshman @ Laxman Bagti (34 yrs) S/o-Riju Bagti both of Vill-Khedatard, Dist-Purulia. and seized articles (i) one iron rod length approx.-34 inch (ii) One iron hammer with wooden butt length approx 12 inchi (iii) Two plastic torch (iv) One iron chopper length approx 12 inch & breadth approx. 02 inch & (v) one knife with plastic butt length approx. 9 inchi, lodged complain against them, to the effect that on 15/12/2023 at about 21:20 hrs, IC Joypur PS received a credible tip that a gang of dacoits in a patch of Deulghata Jungle near Jaltanki more and they were preparing themselves for committing dacoity at Deulghata side. This matter was noted down to the GDE vide Joypur PS GDE No-754, Dated-15/12/2023. On getting the tip off as per kind order myself accompanied with force namely C/-181 Rabban Sekh, C/-3017 Pradip Mallick and NVF/-818 Dayamay Kumar all of Joypur PS vide CC No-2974/23 dated-15/12/2023 immediately proceeded to the anticipated place of assembly to work out the information and reached near Jaltanki at 21:40 hrs keeping the Police vehicle and started to proceed for the anticipated place on foot. at 21.45 hrs reached at anticipated place and we noticed in a glimpse of light that 5/6 persons assembled in the beginning of the jungle by the side of village road near Jaltanki more and those persons are whispering from which it was clear that they are preparing themselves to commit dacoity as it could be audible from the parlance of the assembled criminals. We cordoned them cautiously. Then after disclosing our identity, I commanded them to surrender but they did not pay any heed and tried to flee away. We succeeded to nab in rounding up only 02 (two) of them at 21.50 hrs while the rest 03/04 were manage to escape despite of a hot chase after them. They disclosed their identity as mentioned above. We told them we want to searched them, if necessary, they can search us, but they told they are not willing to search us, then after observing all formalities I searched the above noted apprehended persons and recovered (i) One iron chopper length approx 12 inch & breadth approx. 02 inch & (ii) one knife with plastic butt length approx. 9 inch from their possession and found (i) one iron rod length approx.-34 inch (ii) One iron hammer with wooden butt length approx 12 inchi (iii) Two plastic torch from the place of assembly of the accused persons. After observing all formalities in between 21:55 hrs to 22:25 hrs I, seized (i) one iron rod length approx.-34 inch (ii) One iron hammer with wooden butt length approx 12 inch (iii) Two plastic torch (iv) One iron chopper length approx 12 inch & breadth approx. 02 inch & (v) one knife with plastic butt length approx. 9 inch from the place of assembly and from their possession under proper seizure list as well as label duly signed by apprehended persons and witnesses as alamat property. On interrogation they confessed their guilt for committing dacoity at Deulghata side. I am to note here that I have to conduct search & seizure in presence of Police witnesses as because as it was dead hour of night and it was a lonely place. Under such circumstances it is reasonably believed that the above noted apprehended persons were assembled there for committing dacoity. So, after observing all formalities I arrested them after preparing arrest memo and ground of arrest duly communicated to them.

Therefore, I pray that a specific case may kindly be registered against the arrested accused persons namely (1) Binod Bagti (39 yrs) S/o-Banku Bagti (2) Lakshman @ Laxman Bagti (34 yrs) S/o-Riju Bagti both of Vill-Khedatard, Dist-Purulia under proper section of law.
