During the inspection theft of electricity was detected U/S-138(1)(a) & 138 (1) (b) of the Electricity amendment Act-2007 i.e. he was consuming electricity unauthorisedly by reconnecting of his energy ,having meter no GO2044758 and Consumer ID 202434428 of WBSEDCL with electric line being the property of a licensee when the said electric line has been disconnected

From the above inspection it was found that he was using total load of electrical equipment
