I do hereby lodge a complaint empowered by enabling the electricity act 2003 subsequently electricity amendment Act-2007 to the effect that S.K Jumman S/O-Late-S.K Jakir Village - Shikaripara, Post- Kashipur, PS-kashipur, Pin-723132, Dist. - Purulia was enjoying electricity unauthorizely by reconnecting of his energy meter with electric line which was disconnected long ago due to non-payment of electric energy bill, he has committed theft of U/S-138(1)(a) & 138 (1) (b) of the Electricity amendment Act-2007 on 18.12.2023 at 4.05 PM I Sri Somnath Burman AE(E) & Station Manager of Kashipur CCC, WBSEDCL along with.

2. Sri Suprakash Layek, JE(E), Kashipur CCC, WBSEDCL
3. Sri Samir Roy, technical Supervisor, Kashipur CCC WBSEDCL

Entered the premises of Sri S.K Jumman S/O-Late-S.K Jakir Village - Shikaripara, Post- Kashipur, PS-kashipur, Pin-723132, Dist. - Purulia and inspected his premeses. During the inspection theft of electricity was detected U/S-138(1)(a) & 138 (1) (b) of the Electricity amendment Act-2007 i.e. he was consuming electricity unauthorisedly by reconnecting of his energy, having meter no GO2044758 and Consumer ID 202434428 of WBSEDCL with electric line being the property of a licensee when the said electric line has been disconnected.

From the above inspection it was found that he was using total load of electrical equipment

Out of which I seized the following electric items

- 1) WBSEDCL electric meter having meter no GO2044758.

Siezure list is prepared at the site and accused person/actual use refused to sign the inspection report, and seizure list. The inspection team left the premises at 04.20 P.M on dated 18.12.2023. The accused person has committed an offence U/S-138(1)(a) & 138 (1) (b) of the Electricity amendment Act-2007

You are requested to take cognizance of the complaint and treat it as F.I.R and action may be as per rule.
