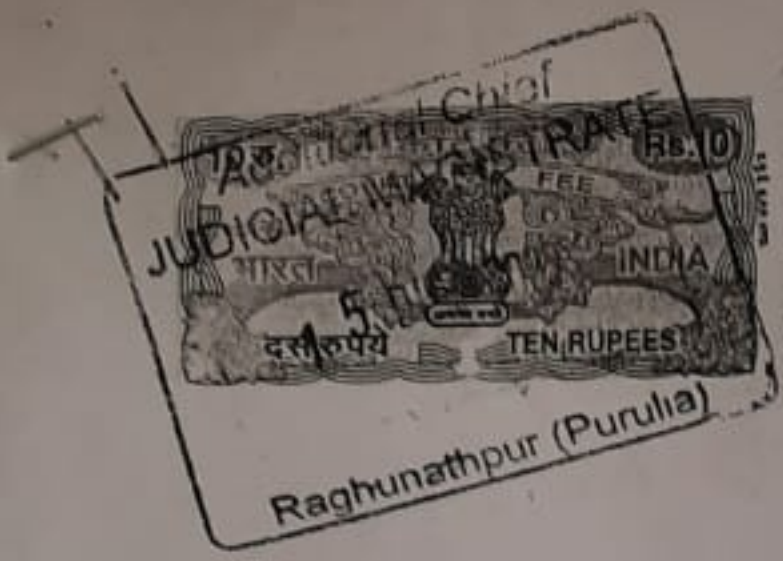
The humble petition on behalf of the

Most respectfully sheweth:-

1. That the daughter of the complainant TUMPA DAS married with Mihir Das S/O Pashupati Das of vill:-Jorthol, 10 yrs. back and thereafter several times during this period she was tortured mentally and physically by Mihir Das and his parents. On 02-12-2023 at about 12 noon, the complainant informed that her daughter TUMPA DAS died. Tumpa Das was the mother of two daughters namely:- i) Mallika Das and ii) Koyel Das.

2. That when the complainant got the heart-blusting sad news of the death of his daughter Tumpa Das, he at a glance proceeded towards jorthol village (in-laws house of his said daughter) alongwith brother Kamal Das, brother's wife Uttam Das, son-Ananda Das & brother Barun Das. At about 1-30 P.M. on 02-12-2023 complainant and others reached to the place of cemetery (Samsan Ghat) wherein they saw that the dead body of Tumpa Das being burned.
