I do hereby lodge written complaint empowered by enabling the electricity act 2003 subsequently amendment act 2007 to the effect that Sri Dilip Sahis,S/O-Kalachand Sahis,Village-Pirrah,P.O-Pirrah,P.S.-Kenda,Dist-Purulia,Pin-723128 has committed theft of electricity through direct hooking from the nearest pole of W.B.S.E.D.C.L at his domestic premises under section-135 clause (1)(a) of the electricity act subsequently amendment act-2007 on 14.12.2023 at about 1:00 P.M.

I Sri Saikat Mallick,S/O-Himadri Mallick,A.E & S.M of Puncha CCC along with 1) Sri Somnath Soren(J.E Gr-I) under puncha CCC,S/O-Lt. Pannalal Soren 2)Sri Sandip Mahato(O.E.) under Puncha CCC,S/O-Lt. Brindaban Mahato 3)Sri Soumajit Rakshit(O.E)under Puncha CCC,C/O-Sanjit Kumar Rakshit and other technical staff attached to Puncha CCC entered the premises of Sri Dilip Sahis,S/O-Kalachand Sahis, Village-Pirrah,P.O-Pirrah,P.S.-Kenda, Dist-Purulia, Pin-723128 and inspected his premises. During the inspection theft of electricity was detected through direct hooking from the nearest pole of W.B.S.E.D.C.L under section 135(1)(a).

The accused person was consuming electricity dishonestly through direct hooking from the nearest pole of WBSEDCL causing considerable revenue loss of WBSEDCL, during inspection total load found was 0.28KW.From the above hooking arrangement he uses the following electrical equipments-

1)Fan-01 nos(80 Watt) 2) Bulb-1 no(100 Watt) 3)LED light-2nos(10Watt each) 4)TV-01 no(80 Watt).

The following items were seized from the house of the accused person-

1) 2 Core PVC service cable 20(Twenty)meter approx.

Seizure list was prepared at the site and the accused person refuses to sign. The inspection team left the premises at about 01:30P.M. On 14.12.2023. The accused person has committed an offence U/S 135 (1)(a) of E.A-2003 subsequently amendment E.A-2007. You are requested to take cognizance of this complaint and treat it as F.I.R and action may be taken as per rule.
