Dear Sir,

I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Dhiren Mahali, S/O- Balai Mahali of Village- Chandra, P.O- Chandra, P.S.- Kenda, Dist - Purulia, has committed theft of Electricity U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

On dated 19.12.2023 at about 11.15 am I, Sri Swarup Mandal, Station Manager, Manbazar Customer Care Centre, WBSEDCL along with,

1) Sri Asit Baran Kundu, Junior Engineer, Manbazar CCC, WBSEDCL

2) Sri Sourav Mukherjee, Senior TSH, Manbazar CCC, WBSEDCL

entered the premises of Dhiren Mahali, S/O- Balai Mahali of Village- Chandra, P.O- Chandra, P.S.- Kenda, Dist -Purulia and inspected his premises and found that he was using electricity unauthorisely by direct hooking from LTOH line of WBSEDCL.

During inspection, theft of electricity was found, i.e., he was using electricity dishonestly U/S 135(1)(a) was detected. It was also found that he was using the following electrical equipments -

1) One no incandescent lamp of wattage 60 watt.

2) One no table fan of wattage 60 watt.

out of which we seized the following -

1) Single core flexible wire of length about 10 meter with a lamp holder.

2) One no incandescent lamp of wattage 60 watt.

The seizure list is prepared at the site and the accused person refused to sign in the seizure list. The inspection team left the above premises at about 11.35 am on dated 19.12.2023. The accused person has committed an offence U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

You are requested to take cognizance of the complaint and treat it as F.I.R. and action may be taken as per rule.
