Sir,

In producing herewith the accused person namely Deben Mahato @ Laden (23 Yrs.), S/O- Santosh Mahato of Vill- Rajdih, Po- Bamundiha, PS- Barabazar, Dist- Purulia and also seized vehicles one Blue colour Tractor having Registration No.-WB 55A /0368 Engine No- D21569, Chassis No -4212002 attached with Trolley without number plate loaded with sand approx. 100 cft . The fact of the case in brief is that on 20/12/2023 I along with C/334 Arup Kumar Khawas and JC/1332 Sujit Kr. Mahato both of Kenda PS were performing special mobile duty. During mobile duty on 20/12/2023 at about 11:15 hrs when we reached Keshya More to Tokoriya pitch road near Kamta village more under Kenda P.S found that the above noted tractor was coming from Tokoriya village side. On seeing the Police party driver of the said vehicle stopped his tractor in a distance and he tried to flee away after keeping the tractor near at Kamta village more but we manage to detain the driver of the said tractor. On demand the driver of the said vehicle failed to produce any valid documents in respect of the said tractor and loaded sand. It ascertained that the owner and driver of the said tractor loaded the said sand by illegal manner for selling the same to make profit by dishonestly in a clandestine business. So I seized the Blue colour Tractor having Registration No.-WB 55A /0368 Engine No- D21569, Chassis No -4212002 attached with Trolley without number plate loaded with sand approx. 100 cft. In between 11:25 Hours and 11:45 Hours under proper seizure list in presence of available witnesses duly signed by them and also arrested the driver Deben Mahato @ Laden S/O- Santosh Mahato of Vill- Rajdih, Po- Bamundiha, PS- Barabazar, Dist- Purulia of the said tractor at 11:55 hours after preparing memo of arrest duly signed by the accused driver. I also informed him regarding ground of his arrest and arranged to inform his relatives. Thereafter arrange driver from my source and brought the tractor at Kenda PS. So there have sufficient reason to belief that driver and owner of the said seized tractor procured the said sand by fraudulently means or theft by any means for transporting the same to clandestine business.

Under the above facts and circumstances kindly take lawful action against the owner and arrested driver of the Blue colour Tractor having Registration No.-WB 55A /0368 Engine No- D21569, Chassis No -4212002 attached with Trolley without number plate loaded with sand approx. 100 cft.
