P.M.

During the inspection theft of electricity was detected i.e. he/she was using electricity dishonestly by drawing illegal hooking from the nearest LTOH line of WBSEDCL i.e. U/S 135(1/a) was detected.

Out of which I seized the following.

1. PVC two core cable fitted with hooking device approx length 23 feet's along with two bulb one heater.

Seizure list was prepared at the site and accused person signed.

The inspection team left the premises at 01.40. P.M on 12.12.2023. The accused person has committed an offence U/S 135(1)/(a) of the electricity act-2003 & subsequently electricity (Amendment) act-2007. You are requested to take cognizance of this complaint and treat it as F.I.R. and action may be taken as per rule.
