
Sir,

In producing here with 01 (one) vehicle TATA (407) having Registration No. WB-37/7610 loaded with approx 07 (Seven) TN of coal, also taken sample of 05 kg from the TATA 407, to the effect that I, ASI Janardan Kumar along with C/1524 Krishna Ch Mahato, C/297 Apurba Pandey both of Kotshila PS, Dist-Purulia vide CC No. 3464/23 Dated 15/12/2023 were engaged in day mobile duty and at 08.30 hrs (on 15.12.23) myself along with force had been at Durgu Morh on Purulia-Ranchi Pitch Road (SH-4A) under Kotshila PS Dist-Purulia and performing Naka Checking of vehicle, at that time we notice above noted vehicle was coming from Jhalda side via SH-04A towards Purulia. On seeing the police party, the vehicle stop at a distance, which made us suspicious, we chased, reached near the vehicle and we found the driver had fled. According I search the vehicle, found its Reg. No WB-37/7610 and found that the vehicle (TATA-407) was loaded huge quantity of coal. Therefore I waiting for long time for the owner/driver/claimant of the vehicle but no one turn up till 09.15 hrs on 15.12.2023 as claimant of this vehicle. So it is reasonable to believe that the driver & owner of the above noted vehicle (TATA-407) collected the said coal either by theft or by any other fraudulent means from anywhere and transporting the same to earn money for wrongful gains. As such, there is every reason to believe that the above noted vehicle (TATA-407) transporting coal illegally. Accordingly I informed my O/C Kotshila PS and as per his direction, I seized the 01 (one) Vehicle (TATA-407) having Registration No. WB- WB-37/7610 loaded with approx 07 (Seven) TN coal under proper seizure list in between 09:25 hrs to 09:35 hrs & label duly signed by witnesses after taking sample of 05 kg coal from the seized vehicle (TATA 407).

After that I turn up at PS along with seized vehicle loaded with coal as per direction of O/C Kotshila PS myself submit complaint as a suo-moto to start a specific case as per law.

I therefore pray before you, kindly lodge an FIR against the owner & driver of the vehicle having registration NO- WB-37/7610 as per law and arrange for its investigation.


