Entered the premises of ANIL CH. BAISNAB, S/o- Lt. JOTY DAS BAISNAB, resident at DURGU, PS- Kotshila, Dist-Purulia having consumer Id- 242007760, Meter no TS258279, present reading 4492 and inspected his/her premises. During the inspection theft of electricity was detected i.e. by passing the energy meter i.e. U/S 135(I)/(b) was detected. The details of passing the arrangement was damage installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his house without energy registration in WBSEDCL energy meter.

From the above by-passing system he/she uses the following electrical equipments.

- 1. Electrical Bulb- 06 nos.
- 2. Color T.V- 01 no.
- 3. Electric Fan 03 nos.
- 4. Toto- 01 no.
 - Out of which I seized the following.
- 1. One single phase energy meter & approx 2 ft. 2 core PVC cable with bypassing arrangement.
