Dear Sir,

I am writing to bring to your attention a serious incident that occurred on 18.12.2023 at approximately 12:30 hrs and to formally request the registration of a First Information Report (FIR). The incident involves the physical assault on Mr. Buneswar Rajwar, S/O: Late Sri Hari Rajwar, a member of the Murulhar HT maintenance team Of Murulhar 33/11 KV Substation, by Mr. Haren Gope, S/O: Bhagu Gope of Vill – Gawaladih P.O- Jidaru P.S – Kotshila Dist – Purulia, with a bamboo stick.

On the mentioned date and time, Mr. Buneswar Rajwar and the HT maintenance team were engaged in repair and maintenance work on the 33 KV Jhalda Murulhar feeder as part of their routine activities. Unfortunately, during their duties, Mr. Haren Gope initiated a physical assault on Mr. Buneswar Rajwar, causing harm and distress.

In light of the severity of the situation, we urge you to treat this incident as an FIR. We trust that you will take the necessary legal actions to ensure justice is served, and those responsible for this assault are held accountable under the law.

Your prompt attention to this matter is highly appreciated. We have confidence in the capabilities of the Kotshila Police Station to handle this case effectively and bring the culprits to justice.

Thank you for your cooperation and commitment to upholding the law and ensuring the safety of our community.
