I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that Kajal Kumar, S/O-Karam Kumar of Vill- Dakhin Tatuara, P.O-Tatuara P.S-Kotshila, Dist- Purulia has committed theft of electricity U/S 135(1)(a) of electricity act 2003 subsequently amendment act 2007.

On 21.12.2023 at about 02.35 P.M I, Sri Rabindranath Das, (Age- 46 yrs), S/O- Sri Murari Mohan Das, AE & Station Manager, Joypur-CCC along with Raushan Kumar, JE(E) Gr-II, Joypur CCC and Sibaram Mahato, Gr-I TSH, Joypur CCC entered the premises of Kajal Kumar, S/O-Karam Kumar of Vill-Dakhin Tatuara, P.O-Tatuara P.S-Kotshila, Dist- Purulia and found that Kajal Kumar, S/O-Karam Kumar was enjoying electricity unauthorizedly drawing power from the LT DB box of WBSEDCL through black colour 2 core 4 Sq.mm Aluminum cable by means direct hooking from distribution box to his domestic premises and connected load found 1.46 KW. As that Kajal Kumar S/O-Karam Kumar committed theft of electric power. So, I seized the following articles after preparing the seizer list in presence of Raushan Kumar, JE(E) Gr-II, Joypur CCC and Sibaram Mahato, Gr-I TSH, Joypur CCC. The inspection team left the premises at 03.00 P.M.
