I do hereby lodge a Complaint empowered by enabling the Electricity act 2003 Subsequently Electricity (Amendment) Act-2007 to the effect that Md ASIK Khan s/o Lt Md Mustakim Khan of village Manbazar. P.S.-Manbazar, Dist-Purulia, has committed theft of Electricity u/s 135(1)(b) of the Electricity (Amendment) Act-2007.

It is mention that Service Connection effected against Mustakim Khan father of Md ASIK Khan having Consumer ID-2420A1400, Meter No- L 1759598.

On dated 06-12-2023 at about 04-11 PM. I Sri Swarnup Mandal AERSM Manbazar ccc WBSEDCL alongwith Sri Anup Ks. Mandi, SE(E) Purulia Regional office, Sri Prasenjit Chakraborty JE(C) Gr.I, Sri Santu Ghali JE Gr. II and Somenath Lahar Hy Sr LM. Manbazar ccc entered the premises of Md ASIK Khan reside at vill- Manbazar. P.S.-Manbazar. Dist-Purulia and inspected his premises and found that he was enjoying electricity unauthorisely i.e by passing of energy meter by cutting incoming Service Cable.

During inspection- theft of electricity was found i.e he was using electricity unauthorisely u/s 135(1)(b) was detected. It was also found that he was using following electric equipments

- ① Refrigerator 1 no 180 Watt
- ② Ceiling fan 4 nos 60 watt each.
- ③ 9 nos 12 watt nos 9 watt LED Bull.
- ④ Heater 1 no 1000 Watt.
- ⑤ Water filter 1 no 60 watt
- ⑥ Sewing machine 1 no 100 watt
- ⑦ Exhaust fan 1 no 45 Watt
- ⑧ TV 2 nos 100 watt each.
- ⑨ Tube light 2 nos 20 watt each.
- ⑩ 1 no. water pump 1 HP.

The Seizure list is prepared at the site and the accused person refused to sign in the seizure list. The inspection team left the above premises at about 04.30 PM on dated 06.12.2023. The accused person has committed an offence u/s 135 (i) (b) of the Electricity Act 2003 (Amendment) Act 2007.

The Service Connection has been disconnected on 06.12.2023. you are requested to take Cognizance of the Complaint and treat it as FIR and action may be taken as per rule.


