



I ASI Gautam Sen of Manbazar PS do hereby lodge a suo motu complaint against 40/50 unknown villagers of Bortore village under Manbazar PS to the effect that, on 17.12.2023 at about 09.05 hrs while I was engaged for day mobile duty with c/824 Mahananda Raut, NVF 1060 Rabindranath Mahato vide cc no—2727/23 dt-17.12.23 and GDE no- 710 dt-17.12.2023 received a telephonic information that an agitated mob detained a person at Bortore village and as per direction of OC Manbazar PS myself along with the force left to work out the information.

At about 09.15 hrs, while we reached at Bortore village found that an agitated mob have surrounded a man who has already been manhandled by that mob causing bleeding injuries on his person. I tried to rescue the person from the grip of that mob but they restrained us and deterred the police party from discharging our bona fide government duty. I tried to make them understand the legal aspects but the agitated mob didn't pay any heed towards my appeal. Then I informed the matter to the PS and after sometimes, being reinforced by SI Prabir Dey of Manbazar PS, managed to rescue the person from the grip of the mob. During interrogation it could be learnt that his name is Sanat Gope s/o- Lt Anil Gope of Vill- Bortore, PS- Manbazar. it is to note here that villagers have suspected him as a murderer of his wife and assaulted brutally resulting several injuries on his person.

Since Sanat Gope has sustained several injuries on his person, he, after recovery, was taken to Pucha BPHC by SI Prabir Dey for his treatment as the villagers of Bortore were also assembled at Manbazar BPHC.

Hence, a specific case may kindly be started against 40/50 villagers of Bortore village who manhandled that person and deter the police party from performing our Govt. duty.
