To The Officer In-Charge Neturia Police Station Purulia

Sub: Lodging of F.I.R of theft of Electricity against Sk Mintu, S/o Md Islam at his Domestic premises at Inanpur, P.S.-Neturia and thereby committed an offence punishable U/S 135(1)(a) of Electricity Act 2003 amended in 2007.

Dear Sir.

This is to inform you that, I Sri Dhritiman Sardar(26), S/O – Rupal Sardar, A.E. & Station Manager of Saltore CCC of WBSEDCL do hereby lodge complaint against Sk Mintu, S/o Md Islam of Vill.-Inanpur U/s 135 (1) (a) of Electricity Act 2003 amended in 2007 regarding theft of Electricity. We received an information to the effect that Sk Mintu, S/o Md Islam residing at Inanpur was committing theft of Electricity at his Domestic premises by Direct hooking.

Acting on this information this day 05.12.2023, I alongwith Sri Partha Chakraborty, D.E.(S & LP) of Purulia Region Office, Sri Promod Ranjan Barman, S.O. of Purulia Region S & LP Unit, Sri Dayamay Mahato, Sr. TSH of Purulia Region S & LP Unit and Sri Souvik Mudi, J.E.(E) Gr.-II and Sri Shrabanta Mondal, Hg Sr L.M. of Saltore CCC had been to the house of Sk Mintu at the above mentioned address. He was present at his house. We contacted him and disclosed our identity to him. On being asked he allowed us to inspect the Energy meter of WBSEDCL installed at his domestic premises against the name of the consumer namely Sk Mintu.

Also search for local people as witnesses during our inspection of the Energy meter of the said premises but none came forward though some local people gathered there. The premises was a one storied building and the meter is installed at Right hand side wall of the entrance of that premises. Immediately, a notice was prepared duly signed by the consumer representative served upon the consumer and held inspection.

During inspection, it was detected that, Sk Mintu was using Electricity illegally in his Domestic premises by direct hooking from nearest pole of WBSEDCL without any connection with the energy meter installed at Domestic premises bearing meter No: DDG250366 in the name of Sk Mintu at the said premises to commit theft of Electricity.

Immediately, on my direction Sri Souvik Mudi, J.E.(E) Gr.-II and Sri Shrabanta Mondal, Hg Sr L.M. of Saltore CCC disconnected the Illegal Hooking connection and above mentioned service connection. Sk Mintu was shown the illegal hooking connection but being asked he could not render any satisfactory explanation. He was informed about the offence committed by him and its penal provision.

P.T.O.

Sri Partha Chakraborty, D.E.(S & LP) of Purulia Region Office prepared inspection report in his presence and witnesses at the spot and load assessed as 1.51KW. The details of inspection has been mentioned in the inspection sheet attached herewith.

From the evidence so far collected from the inspection of Sk Mintu, it is well established that Sk Mintu was consuming Electricity illegally in his Domestic residence and for this activity of theft the WBSEDCL has incurred huge loss of revenue.

Sri Partha Chakraborty, D.E.(S & LP) of Purulia Region Office prepared Seizure list in respect of the said premises in presence of the consumer and witnesses at the spot.

The inspection was held between 12:10PM to 12:40PM today after observing all legal formalities.

It is well evident that accused Sk Mintu, S/o Md Islam of Inanpur has committed offence punishable U/S 135(1)(a) of Electricity Act 2003 amended in 2007.

You are requested to take cognizance of this complain & treat it as FIR
