Dear Sir,

I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that **Swapan Kumar Banerjee C/O- Mohan Banerjee of Parbelia Bazar P.S -Neturia, Dist- Purulia** has committed theft of Electricity u/s 135 (1) (a) of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On **15.12.2023** at about **04.15 PM** I, Dhritiman Sardar S/O- Rupal Sardar, aged about 26 years, AE & SM Saltore CCC, along (1) Sri Shrabanta Mandal, Linesman (2) Sri Sibdas Ball, J.E. (Gr-I) both attached to Saltore CCC and others had been to Parbelia Bazar for routine inspection purpose. During inspection it was found that **Swapan Kumar Banerjee C/O- Mohan Banerjee** was consuming electricity dishonestly and unauthorisedly in his commercial premises by means of direct hooking from nearest LTOH line ,inspite of having one bonafied connection against ID no-242039117 and without registering the energy meter consumed in the meter which resulted causing loss of revenue of WBSSEDCL ,Total load found to the tune of 2.1 kva.

As theft of electricity was detected during inspection the illegal hooking line was disconnected and two core flat type cable length approx. four meter with hooking device two numbers used for the illegal activity has been seized under memo of seizure list in the presence of witnesses but the accused person signed on Notice & Inspection Sheet but denied by putting his signature in the Seizure List and label. The above seized materials duly packed and labeled at the inspection site. The service connection has been disconnected from the pole side .The inspection team left the aforesaid premises at about **04.25 PM**.

Thus the accused **Swapan Kumar Banerjee C/O- Mohan Banerjee of Parbelia Bazar P.S -Neturia, Dist- Purulia** have committed an offence **u/s 135(i)(a)** of the Electricity Act 2003 read with Amendment Act 2007.

You are requested to take cognizance of this complain treating it as FIR.
