I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sri Gorachand Karmakar S/O- Tarapada Karmakar of Village- Shoyar, P.O- Anara, P.S- Para, Dist-PURULIA has committed theft of Electricity U/S-135 (i) (e) of the Electricity (Amendment) Act-2007.

On dated 13/12/2023 at about 2.40 pm, Sri Sutanu Goswami, Station Manager Anara CCC Customer Care Centre, WBSEDCL along with,

- 1) Sayandeep Paul (JE-11), Anara CCC
- 2) Spandan Maji (Sr. OF), Anara CCC
- 3)

Entered the premises of Gorachand Karmakar, S.O- Tarapada Karmakar of Village- Shoyar, P.O- Anara, P.S- Para, Dist-Purulia and inspected his premises.

During inspection theft of Electricity was found, i.e. he/she was using Electricity dishonestly by unauthorisedly distributing electrical power to the disconnected/ deemed premises of Rabin karmakar by using a PVC flexible twisted copper red and black wire along with holder. The consumer id and meter number of the accused person are

From above observations under electricity act 2003 theft of electricity was detected U/S 135(i) (e).

From the above system he/she was using the following Electrical equipments i.e.

- 1) Fan - 1 Nos. = 80 W
 - 2) Led - 4 Nos - 40 W
 - 3) TV - 1 No(s) = 150 W
- Total 270 watt

Out of which we seized the following:

PVC flexible twisted copper red and black wire along with holder approx 5 mtrs. in length.

The seizure list are prepared at the site and the accused person refuse to signed in the seizer list.

The inspection team left the above premises at about 2.55 pm on dated 13/12/2023 The accused person has committed an offence U/S-135(i) (e) of the Electricity (Amendment) Act-2007.

You are requested to take cognizance of the complaint and treat it as F.I.R and action may be taken as per Rule.
