Dear Sir,

I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sri Nimai Ch Majee, S/O- Lt. Kalipada Majee of Village- Shoyar, P.O- Anara, P.S- Para, Dist-PURULIA has committed theft of Electricity U/S-135(i)(a) of the Electricity (Amendment) Act-2007.

On dated 13/12/2023 at about 03:00pm, Sri Sutanu Goswami, Station Manager Anara CCC Customer Care Centre, WBSEDCL along with,

- 1) Sayandeep Paul (JE-II), Anara CCC
2) Spandan Maji (Sr.OE), Anara CCC

Entered the premises of Nimai Ch. Majee, s.o- Lt. Kalipada Majee of Village- Shoyar, P.O- Anara, P.S- Para, Dist-Purulia and inspected his premises.

During inspection theft of Electricity was found, i.e. he/she was using Electricity dishonestly by directly hooking from the nearby WBSEDCL LTOH line with the help of PVC insulated 2 core 4 sq. mm aluminium wire red and black in colour.

From the above system he/she was using the following Electrical equipments i.e. 1) Fan- 4 NOS => 400 watt 2) Led - 5 NOS => 100 watt 3) Tube - 5 NOS => 100 watt 4) TV - 1 NO => 250 watt Total - 850 watt

Out of which we seized the following:

PVC insulated 4sq mm. 2 core aluminium wire red and black in colour approx length 3mts.

The seizure list are prepared at the site and the accused person refuse to signed in the seizer list.

The inspection team left the above premises at about 03:15 pm on dated 13/12/2023. The accused person has committed an offence U/S-135(i)(a) of the Electricity (Amendment) Act-2007.

You are requested to take cognizance of the complaint and treat it as F.I.R and action may be taken as per Rule.
