Respected Sir,

In producing herewith the FIR named accd. person namely Ranjit Sing Sardar (34 yrs) S/O- Nimai Sing Sardar of Vill+PO Tatari PS-Puncha,Dist-Purulia with seizure of 15 ltrs Illicit Country spirit (CHOLAI) in a white colour plastic container which 01(one) ltrs seized as sample in a plastic bottle collected from the container which were seized and labeled under proper seizure list.

I beg to submit that today (29.12.23) at 18.35 hrs while I ASI Chittaranjan Mukhopadhyay along with C/105 Rajesh Kr.Roy and HG/1423 Hemnata Baskey both of Puncha PS were performing Spl Mobile Duty vide Puncha PS GDE No-1117/23 Dated 29.12.2023 and acting on source information after consulting of O/C Puncha PS at about 18.55 hrs reached at Tatari Villegge and after confirmation held raid in the house of Ranjit Sing Sardar (34 yrs) S/O- Nimai Sing Sardar of Vill+PO Tatari PS-Puncha,Dist-Purulia and found that the above noted person was keeping/selling liquor which were kept in his house at Tatari on demand Ranjit Sing Sardar failed to produce any valid document/ authority in respect of selling of liquor as well as nobody turned up to produce any valid documents as such he committed offence / 46 A(c)BE Act 1909 so I arrested on 29.12.23 at 19.05 hrs. U/S 67 BE Act and also 15 ltrs Illicit Country spirit (CHOLAI) in a white colour plastic container which were seized under proper seizure list duly signed by arrested accused & witnesses and labeled out of which 01(one) ltrs seized as sample in a plastic bottle collected from the container at the time of seizure. During arrest, I followed all the guide lines of Ld Apex Court. NHRC & WBHRC and the ground of arrest was duly notified and informed has relative issued arrest memo and handed a copy of the same to arrestee.

The arrested accd person namely Ranjit Sing Sardar (34 yrs) S/O- Nimai Sing Sardar of Vill+PO Tatari PS-Puncha,Dist-Purulia has committed offense U/S 46A (c) BE Act. 1909 for unauthorized possession and sale of liquor

Under the above facts and circumstances I therefore pray that a specific case may kindly be started against Ranjit Sing Sardar (34 yrs) S/O- Nimai Sing Sardar of Vill+PO Tatari PS-Puncha,Dist-Purulia under proper section of law
