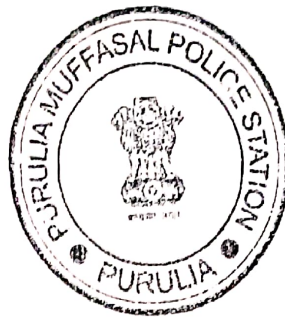

Sub: Prayer for lodging FIR.

Sir,

In producing herewith the arrested alleged drivers namely (i) Ranjit Gorain (43 yrs) S/o- Lt. Sripati Gorain (ii) Niranjan Gorain S/o- Lt. Prafullya Gorain both of Vill- Khojda (Kanali), PS- Purulia (M), Dist- Purulia and seized two motorcycle having registration No- (i) JH09AP/1058 & (ii) JH09BC/9613 loaded with approx 04 (four) Quintal coal from each motorcycles and also taken sample of 02 kg coal from each motorcycles.

I beg to state that on 09.12.2023 at about 07.35 hrs while I, SI Shoumik Acharyya along with (i) ASI Nirod Kumar Mahato (ii) C/- 851 Amrit Banerjee & (iii) C/-248 Arabinda Roy all of Purulia (M) PS, Dist- Purulia vide Purulia (M) C.C No- 5466/2023 Dtd. 09.12.2023 and PS GDE No-749 Dtd. 09.12.2023 were performing mobile duty at PS area I received information from my source that two motorcycle having registration No- (i) JH09AP/1058 & (ii) JH09BC/9613 loaded with illegal coal is going towards Aimundih - Nadiara road. After receiving the information I contacted I/C Purulia (M) PS and as per guidance and instruction we chased the two motorcycles having registration No- (i) JH09AP/1058 & (ii) JH09BC/9613. After a long chase I managed to stop the motorcycles at Aimundih - Nadiara road near Hulka village under Purulia (M) PS at about 16.45 hrs. On seeing the Police party the drivers who were also the owners namely (i) Ranjit Gorain (43 yrs) S/o- Lt. Sripati Gorain (ii) Niranjan Gorain S/o- Lt. Prafullya Gorain both of Vill- Khojda (Kanali), PS- Purulia (M), Dist- Purulia of the motorcycles tried to flee away but we managed to apprehend them. On being asked the apprehended persons disclosed their identity noted above. On demand he failed to produce any valid document in respect of loaded coal. On preliminary enquiry it could be learnt that the drivers who are also the owners of the said vehicle were procuring the said illegal coal from different places and transporting the same in a clandestine manner to another district/state. So, it is reasonable to believe that he was transporting the coal illegally after procuring.

Accordingly I seized the above noted motorcycles loaded with coal approx 04 (four) Quintal coal each motorcycle under proper seizure list duly signed by the accompanied Police persons as there was no availability of any local person, as such I could not collect the signature of the local people in seizure list during seizure. I have taken 02 Kg coal from each motorcycle as a sample after preparing the proper level. The seizure was made between 17.25 to 17.55 hrs. I also arrested the above noted accused persons at 18.05 hrs to 18:10 hrs after maintaining all formalities regarding arrest. Informed them the ground of arrest and issued Memo of Arrest. After that we made a proper arrangement and brought the arrested accused and seized motorcycles loaded with coal at PS for custody.

Therefore, I pray before you that a specific case may kindly be registered against the drivers namely (i) Ranjit Gorain (43 yrs) S/o- Lt. Sripati Gorain (ii) Niranjan Gorain S/o- Lt. Prafullya Gorain both of Vill- Khojda (Kanali), PS- Purulia (M), Dist- Purulia and the owners of the seized two motorcycle having registration No- (i) JH09AP/1058 & (ii) JH09BC/9613 under proper section of law.
