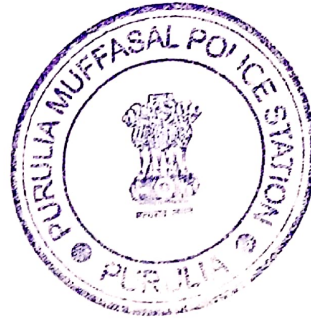

Sir,

In producing herewith the following arrested accused persons namely (i) Suresh Bauri (35 Yrs), S/o-Lt. Kali Bauri, (2) Prasenjit Bauri (23 Yrs) S/o- Daya Bauri @ Dayal of Vill- Chato Chanchra, PS- Purulia (M), Dist- Purulia and seized articles (i) 04 (Four) stones (ii) 02 (Two) bamboo sticks & (iii) 06 (Six) bricks pieces of under proper seizure list.


I would like to state here that today (25.12.2023) I, SI Abhijit Singha along with SI Soumen Kr. Panda and forces went to Choto-Chanchra village for executing warrantee namely Prasenjit Bauri S/o Doya Bauri of Vill- Choto Chanchra, PS- Purulia (M), Dist- Purulia vide NGR No- 3649/23 & Hura PS NCR No. 276/23 Dtd- 03.03.2023, U/S- 194 C MV Act. After arrival at Choto-Chanchra village near the house of Prasenjit Bauri, we found 25/30 persons were gathered with Lathi, Stone and bricks in their hands. We the Police party tried our label best to manage the situation, also requested them to maintain peace and tranquillity in the area but they did not pay any heed of our words and also used abusive languages towards us. After that they became furious and started to shouting "MAR SALA PULISHKE". I informed the matter to I/C Purulia (M) PS and as we were re-enforced by few officers & force immediately. They became more aggressive and tried to overpower the Police personnel and started to assault Police personnel with Stone and Bamboo stick. As a result 03 (three) Police personnel namely (i) SI Soumen Kr. Panda (ii) C/178 Tulsi Mahato (iii) C/1410 Saroj Patra received injuries on their persons. Finding no other alternative as per order I/C Purulia (M) PS I arrested (i) Suresh Bauri (35 Yrs), S/o-Lt. Kali Bauri, (2) Prasenjit Bauri (23 Yrs) S/o- Daya Bauri @ Dayal of Vill- Chato Chanchra, PS- Purulia (M), Dist- Purulia abiding by all formalities and the guidelines of the Apex Court and seized the above mentioned offending articles under proper seizure list. Thereafter the injured Police personnel shifted to Deben Mahato Govt. Medical College & Hospital, Purulia for their treatment. From the statement of arrested accused persons and from our source it is clear that the following persons namely (i) Baru Bauri S/o-Batul Bauri, (ii) Asha Bauri w/o- Jayanta Bauri, (iii) Bilashi Bauri w/o- Batul Bauri (iv) Jayanta Bauri S/o Biswanath Bauri (v) Daktar Bauri S/o- Sudhir Bauri (vi) Bikal Bauri S/o- Daktar Bauri (vii) Binod Bauri S/o- SudhirBauri (viii) Dayal Bauri S/o- Lt. Fagu Bauri (ix) Biswanath Bauri S/o- Lt. Shankar Bauri (x) Shambhu Bauri S/o- Sudhir Bauri all of Vill- Choto Chanchra, PS- Purulia (M), Dist- Purulia along with 10/15 others are fully involved in this crime who obstructed the detailed officers and force in discharging of public function with ulterior motives.

I therefore pray before you that a specific case may kindly be registered against the above noted arrested and other involved accused persons under proper section of law and arrange for its investigation.
