

# Date and place of Occurrence / Incidence:-

On 05.10.2023 at about 9 P.M near Jail Khana More, Purulia, P.S-Purulia(Town), Dist-Purulia(W.B).

Most Respectfully Sheweth:-

1. That, Complainant happens to be a local resident of Mohalla Digudih, P.S-Purulia(Town), Dist-Purulia (W.B)



- 2. That, the husband and son of the complainant namely Sk. Salim and Sk. Raja (elder son) are working as daily labour and does work of loading and unloading vegetables, fishes etc. On 05.10.2023 as they went to their work at Hath and were performing their daily work they had a dispute and quarrel with the accused persons. Wherein the accused persons threatened the husband and son of the complainant with dire consequences even to kill them.
- 3. That on the same day i.e. on 05.10.2023 at about 9 p.m. when the husband, Sk Salim and other two sons namely Sk. Abdul Hakim, Sk. Danish went to Jail Khana More, Purulia for their personal work, the accused persons suddenly attacked them with iron rod, hockey sticks and started assaulting them mercilessly with an intension to kill them as a result of which Sk. Abdul Hakim got badly injured in his hands, his hand got fractured, Sk. Salim husband of the complainant has been assaulted with iron rod over his head and he had to be admitted at the Siddhartha Nurshing Home, Purulia in serious condition.
- That the younger son namely Sk Danish of the complainant was assaulted with fists and blows by the accused persons.
- 5. That as the complainant was busy in treatment of her husband and others, she went to the Purulia Town P.S on 07.09.2023 to lodge a complaint against the accused persons, she submitted a written complaint there but the P.S denied to take the complaint. Later the matter has been informed to the I.C Purulia Town P.S, Purulia in writing, through registered post on 09.10.2023 which was delivered to the Police Station on 10.10.2023 it was received, and the P.S is well posted with the matter, but for reasons unknown no legal action or F.I.R has been lodged against the accused persons.
- 6. That later getting no other alternative the matter has been informed in writing to the Superintendent of Police, Purulia on 12.10.2023 but till date no legal initiatives has been taken by the Office concerned hence the complainant had no other alternative but to approach before the Ld. Court of Law to file this petition praying for taking necessary action against the accused person who has committed illegalities against her.
- That, proper Police investigation should be taken up by treating this complaint as F.I.R
  and action should be taken against the accused persons as per Law for the Interest of
  Justice.
- That, as I.C Purulia Town Police Station, Purulia in spite of getting specific information/ complaint from the complaint has not instituted any F.I.R against the accused person nor any initiative has been taken from the Office of the Superintendent of Police,





- Purulia, let this complaint be forwarded to I.C Police Station, Purulia for treating the same as F.I.R and for undertaking investigation.
- That as required all the formalities of Lodging Complain U/S- 154 Cr.P.C, U/S- 154(3)
   Cr.P.Code has duly been complied with by the complainant. But yet no F.I.R has been lodged against the accused person.
- 11. That the Photostat copies of the application send to the I.C Purulia Town P.S, Purulia, its postal receipt, track report, application submitted before the Superintendent of Police, Purulia are attached herewith this petition with a separate firisti.

Hence it is prayed that Your Honour may graciously be pleased to pass appropriate Orders U/S- 156(3) Cr.P.C by directing the O.C Sadar Women P.S, Purulia to treat the complaint as F.I.R and undertake proper investigation.
