Sir,

In producing herewith one Sk. Samin(38 Yrs) S/o- Sk. Amin of Bhursha, P.O- Beldih, P.S- Arsha, Dist- Purulia alongwith (2) Bidyut Gorai (32) S/O- Ajit Gorai, (3) Biren Gorai(38) S/O- Late Subodh Gorai, (4) Dilip Gorai S/O- Basudeb Gorai, (5) Prasanta Kumar S/O- Jadu Kumar, (6) Sukumar Kalindi(38) S/O- Kitu Kalindi all are of Vill+P.O- Beldih, P.S- Arsha, Dist- Purulia with 05(five) Motor Cycles (1) One Red/Black colour Hero Passion Pro motor cycle bearing no- JH05CG-5016, Chassis no- MBLHAR183JHK29526, Engine no- HA10ACJHK62345, (2) One Black colour Hero Splendor bearing no- JH1BJ-4053, Chassis no- MBLHAR78HHH58685, Engine no- HA10ASN60694, (3) One Black colour Hero Splendor Pro motor cycle bearing no- JH05AN- 1228, Chassis no- MBLHA10ADCHB18238, Engine no- HA10EHCHB22178, (4) One Black & Blue colour Hero HF Deluxe motor cycle without number plate bearing Chassis no- MBLHAR209HGD06055, Engine no- HA11ENHGD06088, (5) One Red & Black colour Hero Super Splendor motor cycle without number plate bearing Chassis no- MBLJARO38J9D03527, Engine no- JA05E0J9D24055 under seizure list which was duly signed by the accused persons as well as witnesses.

I, ASI Raju Mukherjee of Purulia (T) PS performing mobile patrolling duty at PS area and in course of duty at 16:45 hrs my source inform me that one Toto driver of Beldih village under Arsha PS committed theft and sold bikes in Beldih village and others local area. My source also informed me that the said Toto driver presently moving and standing near Purulia Bus stand area. Myself at once informed the I/C Purulia (T) PS regarding the information and myself diarised the matter vide Purulia (T) PS GDE no- 198, dt- 04.12.2023. As per instruction I/C Purulia (T) PS, PC party of the Purulia (T) PS also accompanied with me. Thereafter myself and force left for Purulia Bus stand area and my source identified the accused Sk. Samin, we immediately cordon the person, on asking he disclosed his name as Sk. Samin(38 Yrs) S/o- Sk. Amin of Bhursha, P.O- Beldih, P.S- Arsha, Dist- Purulia. During interrogation in presence of two disinterested persons namely Saharuk Khan (30 yrs) S/O- Lt. Bhola Khan of Husainidih Mohalla, Ward No- 23 and Mongla Ansari (30 yrs) S/O- Idu Ansari of J.K. College Road, Ward 09 both of PS- Purulia (T), Dist- Purulia he confessed that he and other two friends sold stolen bikes in the Beldih village and other villages. Myself and force immediately moved to Beldih village with Sk. Samin. We reached at Beldih village and as per identification of Sk. Samin myself and force conducted raid with the help of local Police in the house of Bidyut Gorai and recovered one Red/Black colour Hero Passion Pro motor cycle bearing no- JH05CG-5016, Chassis no- MBLHAR183JHK29526, Engine no- HA10ACJHK62345 from him. On asking he failed to produced any valid papers or documents in respect of the said motor cycle, he also failed to give any satisfactory answer regarding the motor cycle. I seized the said motor cycle under proper seizure list which is duly signed the accused person as well as witnesses. I have

arrested Sk. Samin and Bidyut Gorai maintaining all legal formalities. Thereafter I conducted raid in the house of Biren Gorai and recovered one Black colour Hero Splendor bearing no- JH1BJ-4053, Chassis no- MBLHAR78HHH58685, Engine no- HA10ASN60694. He also failed to produced any valid papers or documents in respect of the said motor cycle. I seized the said motor cycle under proper seizure list which is duly signed the accused person as well as witnesses and also arrested him maintaining all legal formalities. As per leading statement I also conduct raid in the house of Dilip Gorai and recovered one Black colour Hero Splendor Pro motor cycle bearing no- JH05AN- 1228, Chassis no- MBLHA10ADCHB18238, Engine no- HA10EHCHB22178. On asking failed to produced proper documents and satisfactory answer, so I seized the said motor cycle under proper seizure list which is duly signed the accused person as well as witnesses and also arrested him maintaining all legal formalities. Myself and force also conducted raid in the house of Prasanta Kumar and Sukumar Kalindi respectively. We also recovered from their possession following two motor cycles respectively (1) One Black & Blue colour Hero HF Deluxe motor cycle bearing no- none(without number plate), Chassis no- MBLHAR209HGD06055, Engine no- HA11ENHGD06088, (2) One Red & Black colour Hero Super Splendor motor cycle without number plate bearing Chassis no- MBLJARO38J9D03527, Engine no- JA05E0J9D24055. They also failed to produce any valid papers or documents in respect of said two motor cycles. So I seized two motor cycles in under proper seizure lists which are properly signed by the accused persons as well as witnesses and also arrested them maintaining all legal formalities.

During preliminary investigation, it came to know that a racket is going on, who theft the motor cycles from Tata, Bokaro side and sold these motor cycles among these villagers in very cheap rate without any valid documents/papers.

Under this circumstances, I pray to start a specific case against (1) Sk. Samin(38 Yrs) S/o- Sk. Amin of Bhursha, P.O- Beldih, P.S- Arsha, Dist- Purulia, (2) Bidyut Gorai (32) S/O- Ajit Gorai, (3) Biren Gorai(38) S/O- Late Subodh Gorai, (4) Dilip Gorai S/O- Basudeb Gorai, (5) Prasanta Kumar S/O- Jadu Kumar, (6) Sukumar Kalindi(38) S/O- Kitu Kalindi all are of Vill+P.O- Beldih, P.S- Arsha, Dist- Purulia and others to unearh truth under proper section of law.
