Today, i.e. on 20.12.2023 I, Prashant Kishor (DE&SM), along with Sri Suraj Kumbhakar JE (GR-I), & Sri Deb dulal Banerjee (Sr TSH) of Telkalpara CCC, WBSEDCL conducted a raid programme at village Telkalpara (Locoshedpara) under Purulia(T) P.S. When our team at about 03.25 P.M. entered to the Domestic premises of Rabindra nath Seal, we found that he was enjoying electricity dishonestly by means of Meter Bypass i.e. tampering of meter box and inserting the cable in the incoming side of meter and run domestic appliances, thus WBSEDCL losses revenue. After detection of theft and unauthorized use of electricity illegally and dishonestly the inspection team disconnected the service line.
