Sub: Prayer for starting a specific case against one Wali Islam @ Fawaz (30 yrs), S/O- Sk. Sakir Ali, of S.C Sen Road, Hussainidanga, Ward No-15, P.S- Purulia (T), Dist- Purulia.

Respected Sir,

With due respect I, ASI Nabin Nischit Pandey beg to submit before you that on 21.12.2023 at about 06.05 hrs while myself along with C/295 Badrul Hazari and C/2365 Sourav Shaw, were performing 1st Night mobile & Naka Checking duty vide Purulia (T) PS CC No- 3845/23 Dated-20.12.2023 at Telkal Para on Purulia-Bankura Road (NH-60A) as per kind instruction of my superiors and found that one Black & Silver colour Husqvarna Vitpilen 250 Motorcycle having Regd. No- WB56S-3817 was coming from Surulia side towards Telkal Para with Driving Dangerously. Police personnel of Naka party in proper Police uniform raised hand and directed him to stop the Motorcycle, but said Motorcycle rider violating the Police Signal rash or negligently as to endangered human life which may cause any time accident to the road user. After long chase we can able to apprehend him at Telkal Para Naka Point. On interrogation he made incoherent statement at different time. He disclosed his identity as Wali Islam @ Fawaz (30 yrs), S/O- Sk. Sakir Ali, of S.C Sen Road, Hussainidanga, Ward No-15, P.S- Purulia (T), Dist- Purulia. On being asked he failed to produce any other valid documents of Black & Silver colour Husqvarna Vitpilen 250 Motorcycle having Regd. No- WB56S-3817. Hence he violated the provision of Section 279 IPC & R/W Section-184 MV Act. So I seized the Black & Silver colour Husqvarna Vitpilen 250 Motorcycle having Regd. No- WB56S-3817, Chassis No- MD2JUEXL0MC077729, Engine No- M-93706111, in-between 06.15. hrs to 06.25 hrs under proper seizure list duly signed by the witnesses and arrested the offending driver namely Wali Islam @ Fawaz (30 yrs), S/O- Sk. Sakir Ali, of S.C Sen Road, Hussainidanga, Ward No-15, P.S- Purulia (T), Dist- Purulia at 06.35 hrs after observing all formalities and explained the ground of arrest, issued memo of arrest. Subsequently the accused driver namely Wali Islam @ Fawaz has been released on bail as the offence is bailable.

So I pray specific case may kindly be registered against the accused namely Wali Islam @ Fawaz (30 yrs), S/O- Sk. Sakir Ali, of S.C Sen Road, Hussainidanga, Ward No-15, P.S- Purulia (T), Dist- Purulia (Rider of Husqvarna Vitpilen 250 Motorcycle) for committing offence U/S-279 IPC & R/W Section- 184MV. Act.
