Dear Sir,

I do hereby lodge complaint empowered by the Electricity Act 2003, Amendment of 2007 to the effect that, the below mentioned accused, has committed theft & unauthorized use of electricity U/S 135 1(a) of the electricity Act 2003, Amendment of 2007 as stated here under.

On 22/12/2023 at 15.05 Hrs. I Sri Subhajit Pratihar, DE & SM Purulia CCC WBSEDCL along with Chanchal Mondal(DE attached to Purulia Regional Office WBSEDCL), Anurag Pandey (OE Purulia CCC), Susanta Baul (JE Purulia Region Office WBSEDCL) went to make an inspection to workout upon a source information regarding theft of electricity for at the domestic premises of Md Shamshad, Son of Md Samsuddin, resident of J.K.College Road, Rani bandh, Purulia(T) Thana, Dist Purulia by serving one entry notic e duly signed by the consumer representative.

During the time of insection at the premises 1 nos of electricity meter was found having serial no L4707944 (Consumer id 242123755, Consumer Name- Md Samsuddin).

It was observed that user Md Shamshad has made unauthorized use of electricity under section 135 1(a) by tapping the service wire of the license and connecting it directly to the wiring to run domestic appliances and hence causing huge loss of revenue to WBSEDCL. From the above arrangement the accused was using Fan 4 nos (80 watt each), Light 8 nos (10 watt each), Pump 1 nos 746 watt, washing machine 500 watt.

After detection of theft & unauthorized use of electricity illegally and dishonestly, the inspection team disconnected the service connections in the premises from pole with the help of LT Mobile Van Team and removed & seized 2 feet service cable with the hooking arrangement & prepared seizure list duly signed by the accused.

The inspection team left the premises at about 14.00 Hrs on 22th DEC 2023.

The accused committed theft of electricity U/S 135 1(a) of the electricity Act 2003, Amendment of 2007.

You are requested to take cognizance of the complaint & treat this as FIR and take necessary action.
