Sub : Prayer for lodging FIR against accused Indrajit Rajwar (35Y), S/O Lt. Anadi Rajwar of Vill.- Gohira, PS - Santaldih, Dist. - Purulia.

Sir,

In producing herewith one arrested accused person named as Indrajit Rajwar (35Y), S/O Lt. Anadi Rajwar of Vill. - Gohira, PS - Santaldih, Dist. - Purulia along with seizure - list and seized items as described below, I beg to state that on 20.12.2023 at about 18.45 hrs I received a source information to the effect that the country spirit has been kept at Gohira village under this PS in the house of above noted accused illegally, with an object to sale. I have informed the matter to I.C. Santaldih PS and this refers to Santaldih PS GDE no. 759, dtd. - 20.12.2023 and as per order of I.C. Santaldih P.S. I along with force left for Gohira village to workout the information with the govt. supplied kit box containing white cloth, sealing wax, seal, papers, carbons, match box, candles etc. I had been to the house of Indrajit Rajwar at Gohira village, P.S. Santaldih at about 19.05 hrs. Seeing police party some unknown persons in front of the house of Indrajit Rajwar were fled away. However, I could detain one among of them and asked about his identity. He disclosed his name and identity as noted above and as well as admitted that he gathered the country spirit for selling and he was the owner of the said house. However, I along with said accused started a search inside the house of Indrajit Rajwar and found the following item in the said house -

**1) Total 40 (Forty) bottles 80UP country spirit (Dil khush) in two box each bottles containing 600 ML market value of each being in total approx Rs. 2200/- (Two Thousand Two Hundred only).**  
02 (Two) bottle of 600 ML taken (Dil khush) out of the above each box as sample packet, labeled and sealed with sealing wax.

I interrogated him about the purpose of the stocking and possessing such country spirit. He replied it was the business of him. On repeated question he told that the persons who fled away were his customers (names of those not known to him). However he could not show any documents/papers in support of the possession as well as sale of the said articles.

As such, I seized the above items as ALAMAT under proper Seizure List between 19.45 hrs and 20.05 hrs & took up one bottle of each box as samples, labeled and sealed accordingly.

Since the allegation against him of possessing, as well as selling the country spirit illegally without any valid papers in his house has prima-facie been made out and for the interest of proper investigation, I arrested the above accused at 20.10 hrs accordingly after maintaining all arresting guidelines.

Therefore, I pray before you to start a case under proper section of law against the said accused Indrajit Rajwar (35Y), S/O Lt. Anadi Rajwar of Vill. - Gohira, PS - Santaldih, Dist. - Purulia.
