Dear Sir/Madam,

I, Samim Ali Molla, S/O- Sabed Ali Molla, the A.E. & Station Manager of Santuri Customer Care Centre being authorized under the electricity Act.-2003 and electricity (Amendment) Act-2007, do here by lodge complaint against Irfan Khan, S/O- Taium Khan, Village- Bheti, P.S.- Santuri for theft of electricity by direct hooking from the nearby LT overhead line of WBSEDCL with the help of PVC cable U/S.- 135(i)/(a) of electricity Act 2003 and electricity (Amendment) Act-2007, as Stated here under:

That on 28.12.2023 at 12.25 hrs. myself along with Sri Prasanta Maji, Junior Engineer (E) Gr.-I, Kiran Kumar Das (Sr. Office Executive) of Santuri CCC inspected the domestic premises of Irfan Khan, S/O-Taium Khan, Village- Bheti, P.S.- Santuri and it is found that, electricity is used at his premises for running his domestic electrical appliances from the nearby LT overhead line of WBSEDCL with the help of PVC cable fitted with hooking device which causing huge loss of revenue of WBSEDCL. Inspection report have been prepared and assessed the load which comes to 0.507 KW. After disconnection of the involved line by maintaining proper safety norms, the portion of two nos. Single core PVC cable approx length of 15 feet each have been seized under proper seizure list. The premises have been left at 12.40 hrs.

Hence, Irfan Khan, S/O- Taium Khan, Village- Bheti, P.S.- Santuri has committed theft of electricity and are liable to be prosecution U/S.- 135(1) (a) of electricity Act-2003 and electricity (Amended) Act-2007.


