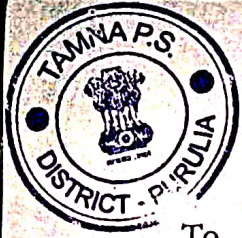

Sir,

I, Gnan Sankar Pati S/o- Ramani Ranjan Pati of Vill+P.O- Chaka, PS- Khatra, Dist- Bankura, ASI of Police of Tamna PS, Dist- Purulia, along with force returned at PS and in producing herewith one blue colour Sonalika D1-35 seized Tractor having Reg. No. WB-55A/6214, Engine No. 3100FL73E638449F3 and Chassis No. FZJST644423SM loaded with sand approx. 100 cft. and lodged this complaint to the effect that on 03.12.2023, myself along with force i) C/195 Santosh Sing Sardar and ii) C/152 Paresh Nath Bouri were performing PS area mobile duty. During my mobile duty at about 22:25 hrs received credible source information that one Blue colour Tractor is carrying sand illegally from Kotlui village side. Accordingly, myself along with force left to work out the said source information. Then, we intercepted the aforesaid tractor near at Belguma Mahatapara under Tamna PS, Dist- Purulia at about 22:45 hrs and found that the above noted tractor was tagged with a trolley loaded with sand (approx 100 cft.). But seeing the Police party, driver of the tractor fled away leaving the said tractor near at Belguma Mahatapara under Tamna PS. We tried to apprehend him but failed. So, there is every reason to belief that the owner and driver of above noted tractor dealing in sand business in clandestine manner. We waited for reasonable time but none came forward and produce any proper challan or any valid documents related to the said loaded sand of above detained tractor. So, I seized the said Blue colour Sonalika D1-35 Tractor having Reg. No. WB-55A/6214, Engine No. 3100FL73E638449F3 and Chassis No. FZJST644423SM along with sand (Approx 100 cft.) loaded trolley. Bring the Tractor at PS after arranging driver from our force.

On return to Tamna PS, kept the aforesaid seized tractor attached with sand loaded (Approx 100 cft.) trolley at PS compound and I do hereby submit written complaint before you to start a specific case against the owner and driver of the said tractor having Reg. No. WB-55A/6214, Engine No. 3100FL73E638449F3 and Chassis No. FZJST644423SM under proper section of law.
