I SI Madan Supakar (52 Yrs), S/o- Lt.Gobinda Ch. Supakar of Vill- Jojodih, PS- Hura, Dist- Purulia, A/P SI of Police, Tamna PS in producing herewith the arrested accused persons namely (i) Samid Khan @ Tinku Khan (34 Yrs), S/o- Lt. Soharab Khan of House No. 98, Mansuri Mahalla, Laludih, Gomoh, PS- Hariharpur, Dist- Dhanbad, Jharkhand and (ii) Md. Riaz Khan @ Bablu Khan (32 Yrs), S/o- Lt. Nasir Khan of Purana Bazar, Chamra Gudam, Gomoh, PS- Hariharpur, Dist- Dhanbad, Jharkhand and seized articles i.e. (i) One white colour Maruti Suzuki Swift vehicle without number plate and Engine number & chassis number in tempering condition (ii) One Vivo V27 mobile hand set, Model No.- V2246 having IMEI 1 No. 869657066738433 & IMEI 2 No. 869657066738425, Storage – RAM 8 + 8 GB, Internal Storage 128 GB (iii) One SIM Card of Airtel vide SIM No. +9194 31377876, ICCID No. 8991000920144359693 (iv) One SIM Card of Jio vide SIM No. +917004056876, ICCID No. 89918560400668828214 (v) One IQ00Z3 mobile hand set, Model No. I2011 having IMEI 1 No. 863999054375810 & IMEI 2 No. 863999054375802, Storage – 6+2 GB, Internal Storage 128 GB (vi) One SIM Card of Airtel vide SIM No. +919801381538, ICCID No. 8991000907990313197 (vii) One Karbonn mobile hand set, Model No. KW201 having IMEI No. 355707810179409 (viii) One Itel Ace hand set, Model No. Ace2N having IMEI 1 No. 351806722559668 & IMEI 2 No. 351806722559676.

I beg to lodge this complaint against both the above noted named arrested accused persons to the fact that, today (11/12/2023) at 19.15 hrs you as O/C of this PS had received a credible source information that the above noted vehicle lifters were coming towards Tamna PS area from Chasmore side riding on a white colour Maruti Suzuki Swift vehicle without number plate in order to commit theft of vehicles at Tamna PS area and as per your order I along with C/152 Pareshnath Bouri and C/195 Santosh Sing Sardar left for Simulia More on Purulia-Tata road around 19.30 hrs. At 20.05 hrs. a white colour Maruti Suzuki Swift vehicle without number plate could be seen coming towards Simulia More side from Dulmi Side. At once, we suddenly reached middle of the road with guardrails, at Simulia more under Tamna PS seeing us both the above noted accused persons made an attempt to run away leaving the white colour Maruti Suzuki Swift vehicle without number plate but we at once intercepted both of them. The intercepted persons on interrogation made incoherent statement in respect of their identity and about the registration certificate, Insurance

certificate etc and the name of its owner. After repeated interrogation, they admitted that the said white colour Maruti Suzuki Swift vehicle was a stolen one procured by both of them by committing theft. They also stated that they use to tamper both the Engine number and Chassis number in order to make those illegible in order to avoided identification of the original one. They also confessed before all of us that they are professional vehicle lifter and have stolen away many vehicles from different places and sold those vehicles one after another to different customers affixing fictitious number plate with fictitious registration number surreptitiously and earned a lot of money. They also confessed that they had assured to manufacture documents in respect of the sold stolen vehicles and handed over the purchaser shortly. They agreed that they would be able to identify the purchaser of such stolen vehicles, their residential home and would be able to identify the stolen vehicles each of them.

I, as such seized the above noted articles under proper seizure list prepared by me on the spot, from 20.25 hrs to 20.55 hrs in presence of witnesses & I also prepared label in respect of seized article as above and arrested both the intercepted persons as above as disclose by them subsequently after preparing Arrest Memo.

Since the circumstances laid to hold my view and as per believable confessional statement of both the arrested accused persons disclosed an offence u/s 379/411/413/414/467/468/471 IPC committed by them. I pray that a specific case accordingly may kindly be started against both the arrested accused persons and to arrange its investigation.
