I Dr.Debraj Choudhury ,S/O- Debasis Choudhury of Ketka (near ketka primary school) Ward No-09, P.S Purulia (Town), Dist-Purulia, General Duty Medical Officer of Chakaltore RH, want to draw your kind attention to an incident- a person namely Sandip Gope son of Subardhan Gope, Vill+po- Chakaltore , PS-Tamna, verbally abused me & physically assaulted me, while I was on emergency duty on 16/12/2023 at emergency room of chakaltore RH at around 08:45 AM(CCTV VIDEO footage is proof of it). There are other 10 unknown persons with Sandip Gope who were also verbally abused me. As Mr. Sandip Gope was not himself a patient or patient party , the attack was intentional with a motive of murder & causing grievous hurt. This causes left ear pain & mental trauma of mine thus causing delay in lodging FIR.


