I, Sukhendu Mudi, S/O-Lt.Mrityunjoy Mudi, Age-45years , AE & Station Manager, Arsha CCC, WBSEDCL, do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently, the amendment act 2007 to the effect that Achintya Kuri, S/O-Late Banamali Kuri of Village -Sirkabad, PS-Arsha,Dist-Purulia has committed theft of materials U/S 136(1)(a) of electricity act 2003 subsequently amendment act 2007.

On 19.01.2024 at about 14.00 o'clock I visited the premises of Achintya Kuri, S/O-Late Banamali Kuri of Village -Sirkabad and found that he dishonestly removed the energy meter from its place of installation where it was rightfully/ lawfully installed without the consent of WBSEDCL. It is mentioned that outstanding dues of Rs.9764.00 remain unpaid vide consumer id-242094986 against the theft meter having Meter Serial No as B1044643.

Achintya Kuri, S/O-Late Banamali Kuri of Village -Sirkabad, PS-Arsha,Dist-Purulia has committed an offence U/S 136 (1)(a) electricity act 2003(Amendment Act 2007),so you are requested to take cognizance of this complaint and treat it as FIR.
