
Sub: To lodge FIR against owner and arrested driver namely Panchanan Majhi (46 yrs) S/O Late Bilash Majhi of Vill- Sirkabad, PS- Arsha, Dist. Purulia of one Red Colour Mahindra B275 DI tractor having Reg. No. WB55B-3045, Engine No. NLK2EAJ0089, Chassis No. MBNABAEXKLK01061 along with trolley loaded with sand (approx 60 CFT).

Sir,

In producing herewith, 01 (one) Red Colour Mahindra B275 DI tractor having Reg. No. WB55B-3045, Engine No. NLK2EAJ0089, Chassis No. MBNABAEXKLK01061 along with trolley loaded with sand (approx 60 CFT). To the effect that during my spl. mobile duty vide GDE No. 1025 Dtd. 24.01.2024 acting on source information & as per direction of O/C, Arsha P.S, I SI Mrinmay Bhakta of Arsha PS along with (i) C/-15 Susanta Kr. Dey of Arsha PS and (ii) C/315 Joydeb Gorain of SAP 7th BN camp at Arsha P.S, Dist-Purulia reached at Gidhubera Sand Ghat near Gandhabazar village under Arsha PS at 12.05 hrs. We conducted raid at Gidhubera sand ghat on the Bank of Bandu River near Gandhabazar village under Arsha PS and found 01 (one) tractor along with trolley attached with by a hinge was present at Gidhubera Sand Ghat on the Bank of River Bandu. Some persons were loading sand in the attached trolley of said tractor. Seeing the Police party, those persons leaving the tractor (loaded with sand in the attached trolley) at Gidhubera sand Ghat near Gandhabazar village, fled away. We rushed to the tractor and detained the said tractor as well as driver namely Panchanan Majhi (47 yrs) S/O Late Bilash Majhi of Vill- Sirkabad, PS- Arsha, Dist. Purulia. I asked him to show valid document in respect of loaded sand but he failed to produce any document. Hence, I seized the above noted tractor along with trolley loaded with sand (approx 60 cft) with proper seizure list and arrested the driver namely Panchanan Majhi (46 yrs) S/O Late Bilash Majhi of Vill- Sirkabad, PS- Arsha, Dist. Purulia with proper arrest memo & following all the guidelines as laid down by the Hon'ble Apex Court. After that, I brought the tractor and the arrested driver to Arsha PS. As there is every reason to believe that the driver and owner of the said tractor with ill motive were transporting sand illegally without any valid document in support of carrying sand and were doing illegal activities vide Memo No. VI/430/(Part-VIII)/2187/1(51)/M/17 Dtd. 03.07.2023 & Memo No. VI/430/(Part-VIII)/ 3326(51)/M/17 of the DM, Purulia.


Hence, I do hereby lodge this complaint against the driver namely Panchanan Majhi (46 yrs) S/O Late Bilash Majhi of Vill- Sirkabad, PS- Arsha, Dist. Purulia and owner of the above noted tractor having Reg. No. WB55B-3045, Engine No. NLK2EAJ0089, Chassis No. MBNABAEXKLK01061 along with the trolley loaded with sand (approx 60 cft) for investigation.
