I, Sukhendu Mudi, S/O-Lt.Mritunjoy Mudi, Age-45years , AE & Station Manager, Arsha CCC, WBSEDCL, do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently, the amendment act 2007 to the effect that Rasu Majhi, S/O- Late Sonaram Majhi of Village -Raipur, PO-Rangamati,PS-Arsha,Dist-Purulia has committed theft of electricity U/S 135(i)(a) of electricity act 2003 subsequently amendment act 2007.

On 30.01.2024 at about 04.40 pm I, along with Chanchal Mondal,S/O- Dinabandhu Mondal,Divisional Engineer(E),Purulia Regional Office,Dipankar Bera(F&A),S/O-Kanailal Bera, Purulia, Regional Office, and Alimuddin Ansari, Sr. Technical Support Hand, Arsha CCC went to routine inspection at Raipur Village and Illegal Hooking from nearest LT Pole of WBSEDCL for agriculture purpose, PS-Arsha,Dist-Purulia was enjoying electricity unauthorisedly by direct Hooking and enjoying power of WBSEDCL in his premises. The service connection of Rasu Majhi with hooking arrangement disconnected on the spot from nearby LTOH Line of WBSEDCL on 30.01.2024 and dismantled the hooking wire at about 05.05 pm. During inspection we found the electrical load he is enjoying as 0.38 KVA.The inspection team left the premises of the accused person at about 05.10 pm.

Rasu Majhi, S/O- Late Sonaram Majhi of Village -Raipur, PO-Rangamati,PS-Arsha,Dist-Purulia has committed an offence U/S 135(i)(a) electricity act 2003(Amendment Act 2007),so you are requested to take cognizance of this complaint and treat it as FIR.
