This is to inform you that I Sri Sisir Kumar Das (35), S/O – Banamali Das, D.E. & Station Manager of Bagmundih CCC of WBSEDCL received an information to the effect that Jiten Addy, S/o Lt. Anil Addy residing at Mill.- Koreng was committing theft of Electricity at his Domestic premises by bypassing the proper registration of units by tampering the Energy meter.

Acting on this information this day 10.01.2024, I alongwith Sri Partha Chakraborty, D.E.(S & LP) of Purulia Region Office, Sri Promod Ranjan Barman, S.O. of Purulia Region S & LP Unit, Sri Dayamay Mahato, Sr. TSH of Purulia Region S & LP Unit had been to the house of Jiten Addy at the above mentioned address. His Daughter-In-Law i.e. Rakhi Addy was present at house. We contacted her and disclosed our identity to her. On being asked she allowed us to inspect the Energy meter of WBSEDCL installed at her domestic premises against the name of the consumer namely liten Addy.

Also search for local people as witnesses during our inspection of the Energy meter of the said premises but none came forward though some local people gathered there. The premises was a one storied building and the meter is installed at the entrance of that premises. Immediately, a notice was prepared duly signed by his Daughter-In-Law served upon him and held inspection.

energy meter installed at Domestic premises bearing meter No: I025107 in the name of Jiten Addy at the said premises to bypass the proper registration of units by tampering the meter circuit of the meter and seals of the said meter to commit theft of Electricity. Inspection also revealed that Jiten Addy was the actual user of the above mentioned service connection.

Immediately, on my direction Sri Dayamay Mahato, Sr. TSH of Purulia Region S & LP Unit disconnected the above mentioned service connection and removed the Energy meter bearing SI no: 1025107 after securing the installation place of the said meter from any imminent danger in future. Rakhi Addy ile. his Daughter-In-Law was shown the tampered meter but being asked She could not render any satisfactory explanation. She was informed about the offence committed by her father in-law and its penal provision

Sri Partha Chakraporty, D.E.(E) of Purulia Region Office prepared inspection report in his presence and witnesses at the spot and load assessed as 1.3KW. The details of inspection has been mentioned in the inspection sheet attached herewith.

From the evidence so far collected from the inspection of the energy meter of Jiten Addy, it is well established that Jiten Addy was consuming Electricity illegally in his Domestic residence and for this activity of theft the WBSEDCL has incurred huge loss of revenue.

Sri Partha Chakraborty, D.E.(E) of Purulia Region Office prepared Seizure list in respect of the said premises and meter in presence of the consumer representative and witnesses at the spot.

The inspection was held between 12:30PM to 12:50PM today after observing all legal formalities.

It is well evident that accused Jiten Addy, \$\forall Lt. Anil Addy of Vill.- Koreng has committed offence punishable U/S 135(1)(b) & (1)(d) of Electricity Act 2003 amended in 2007.
