Sub: Lodging of F.I.R of theft of Electricity against Sridam Kumar , S/o Lt. Sadhu Kumar at his Domestic premises at Vill.-Bhurshu, P.S.-Baghmundi and thereby committed an offence punishable U/S 135(1)(b) of Electricity Act 2003 amended in 2007.

Dear Sir,

This is to inform you that I Sri Sisir Kumar Das (35), S/O – Banamali Das,D.E. & Station Manager of Baghmundi CCC of WBSEDCL received an information to the effect that Sridam Kumar, S/o Lt. Sadhu Kumar residing at Vill.: Bhurshu was committing theft of Electricity at his Domestic premises by bypassing the proper registration of units by tampering the Service cable of the Energy meter.

Acting on this information this day 10.01.2024, I alongwith Sri Partha Chakraborty, D.E.(S & LP) of Purulia Region Office, Sri Promod Ranjan Barman, S.O. of Purulia Region S & LP Unit, Sri Dayamay Mahato, Sr. TSH of Purulia Region S & LP Unit had been to the house of Sridam Kumar at the above mentioned address. He was present at his house. We contacted him and disclosed our identity to him. On being asked he allowed us to inspect the Energy meter & Service cable of WBSEDCL installed at his domestic premises against the name of the consumer namely Sadhu Kumar i.e. his deceased father.

Also search for local people as witnesses during our inspection of the Energy meter of the said premises but none came forward though some local people gathered there. The premises was a one storied building and the meter is installed at the entrance of that premises. Immediately, a notice was prepared which he refuses to sign served upon him and held inspection.

During inspection, it was detected that, Sridam Kumar had tampered the service cable of the energy meter installed at Domestic premises bearing meter No: L4232276 in the name of Sadhu Kumar at the said premises to bypass the proper registration of units by tampering the service cable to commit theft of Electricity. Inspection also revealed that Sridam Kumar was the actual user of the above mentioned service connection.

Immediately, on my direction Sri Dayamay Mahato, Sr. TSH of Purulia Region S & LP Unit disconnected the above mentioned service connection after securing the installation place from any imminent danger in future. Sridam Kumar was shown the tampered service cable but being asked he could not render any satisfactory explanation. He was informed about the offence committed by him and its penal provision.

Sri Partha Chakraborty, D.E.(E) of Purulia Region Office prepared inspection report in his presence and witnesses at the spot and load assessed as 0.550KW. The details of inspection has been mentioned in the inspection sheet attached herewith.

From the evidence so far collected from the inspection of the service cable of Sridam Kumar, it is well established that Sridam Kumar was consuming Electricity illegally in his Domestic residence and for this activity of theft the WBSEDCL has incurred huge loss of revenue.

Sri Partha Chakraborty, D.E.(E) of Purulia Region Office prepared Seizure list in respect of the said premises in presence of the consumer and witnesses at the spot.

The inspection was held between 01:40PM to 02:00PM today after observing all legal formalities.

It is well evident that accused Sridam Kumar, S/o Lt. Sadhu Kumar of Vill.- Bhurshu has committed offence punishable U/S 135(l)(b) of Electricity Act 2003 amended in 2007.

You are requested to take cognizance of this complain & treat it as FIR
