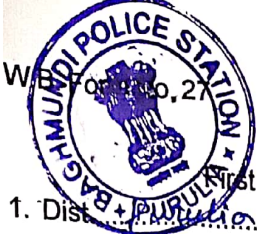

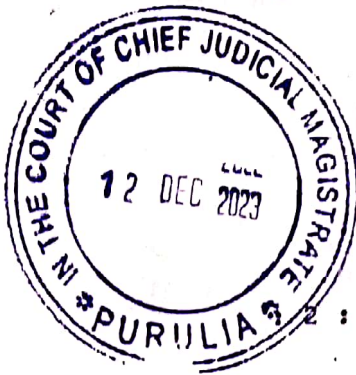

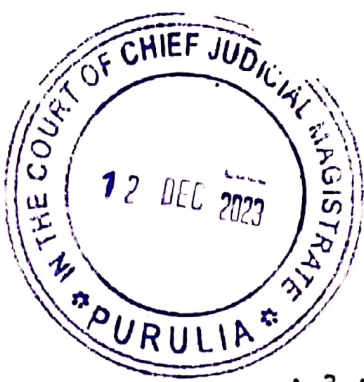

That this is to inform you that I am a resident of Village-Jiling P.O.Hurumda, P.S.-Baghmundi, District-Purulia on 9/9/2023 at about 7.00 P.M.when I was sleeping near my house at that point of time accused <sup>~</sup> Khanu Gope and Bir Singh Gope Son's of Sitaram Gope, Jagannath Gope S/O, Gope and Depen Gope S/O, Lam Gope all are resident of Vill. Jaling, P.O.Hurumda, P.S.-Baghmundi, District-Purulia and Soatan Kumar S/O, Late Biswa Kumar and Laxman Kumar S/O, Late Ajambar Kumar of Village-Birgram, P.O.Birgram, P.S.-Baghmundi, Dist.Purulia came to my house being with Lathi, Iron rod etc and ghrowed me and started filthy languages to wards me. I protested them not to give this type of filthy languages to words me. There after they assulted me and when they fled away they had taken my 4,00000/- (Four Lakh) Rs. from my Bag. It is mention here that on 8/9/2023 I have sold my own land area 16 decimils and I have got consideration money of Rs.4,00000/- (Four Lakh) and said Rs money was in my Bag.

That there after I reported the matter was brought to the O/C, Baghmundi Police station and the Police officer assured me that appropriate legal action would be taken against them but unfortunately till to day no action or no any Specific case has yet been started against the accused person and the accused persons still threatening in various way.
