

Subject: Prayer for lodging specific case against Sabyasachi Goswami @ Kishore @ Ajoy Da @ Babu, aged about 55 years, Son of Late Subhas Chandra Goswami, of Shaktipur, Agarpara, PS. Khardah, District North 24 Parganas, West Bengal, Central Committee Member of the banned organisation CPI (Maoist) for subversive activity.

Sir,

In producing here with the arrested accused person namely "Sabyasachi Goswami @ Kishore @ Ajoy Da @ Babu, aged about 55 years, Son of Late Subhas Chandra Goswami, of Shaktipur, Agarpara, PS. Khardah, District North 24 Parganas, West Bengal" along with seized articles viz.

- 1. - 12. One Booklet of CPI (Maoist) in Bengali styled as "SAMPADAKIYA". It has 29 pages containing speeches against the govt. of our country and inciting common people against the state.

- 13. One Booklet of CPI (Maoist) in Bengali styled as "SUDIP, HAKIM, RAK, OKHNAKAR SUDIPER BANANO ZONAL LEADING TEAMER CHITHIGULIR JABAB" It has 13 pages containing speeches inciting common people.
- 14. One Booklet of CPI (Maoist) in English styled as "Press Release, April 28, 2023- observe the revolutionary May Day. Build Political Militant working class and Peasant movements in India against the fascist BJP four labour codes, anti-farmer's policies and all anti-people policies of the Government. At the end of the second page written" Abhay, Spokesperson, Central Committee.
- 15. One Booklet of CPI (Maoist) in English and Bengali styled as "Press Release, 30 August, 2022 Objurgate the Fascist Government for the death of Pandu Naroti in jail. It has 08 pages. At the end of the first page written" Abhay, Spokesperson, Central Committee.
- 16. One Book of CPI (Maoist) in Bengali styled as "ভারতের উৎপাদন সম্পর্কের পরিবর্তন একটি রাজনৈতিক অর্থনৈতিক পর্যালোচনা"। it is the January, 2021 edition and has 242 pages containing speeches inciting common people against the Indian Govt.
- 17. One Chit (হাত চিঠি) written by hand having the mention of 24.12.23 addressed to Anup in Bengali containing some alert message to his comrades.
- 18. One chit (হাত চিঠি) written by hand containing one poem like writing with the heading "Palestine 2023-Basudev Mitra and at the end of the poem there is mentioned of 23.12.23, MANABIR JONNO. On the reverse page, another poem with the heading "ARJUN UBACH: Basudev Mitra and at the end of the poem there is a mention of "NARI CHETANAR JONNO".
- 19. A maroon coloured "C Type" OTG connector with small silver coloured chain, over which "Ticon® Perfect Trust, TG 20" written in white colour.
- 20. One 9mm Pistol measuring about 07 inches having butt, body, barrel, fitted with magazine loaded with 03 live compatible ammunition. "Made in Germany, Automatic Pistol" in scripted on the body of the said Pistol.
- 21. Cash Rupees Thirty Two Thousand Three Hundred Fifty Six (Rs. 32,356/-) only said to be the raised fund.

22. A black colour bag (back-pack) of Skyway containing four opening and one opening at the lower of the bag for rain protector.

I, Rajat Chowdhury, Inspector of Police, of Bagmundi Police Station, District Purulia, like to inform you that last evening I received an information from Superintendent of Police, Purulia, about the movement of a most wanted senior CPI (Maoist) central committee member at Bengal – Jharkhand Inter State Border Area near the jungle of Chounia, under Matha Gram Panchayat, PS. Bagmundi, Purulia, and as per his kind instruction, I formed a team maintaining all SOP to assist the special team of district head quarter under the leadership of the superior officers. This refers to Bagmundi PS GDE No. 551, dated 11.01.2024. Accordingly I briefed the team comprising of SI Gakul Ruidas, Const. 1539 Buddhadeb Chatterjee, Const. 93 Swarup Layek, Const. 913 Aditya Mondal, Const. 916 Rajkumar Mahato, Const. 2858 Krishanu Patra, Const. 2578 Chanchal Ruidas, Const. and 2587 Debeshis Gorai, and left PS for Banshitanr More, under Bagmundi PS, vide Bagmundi PS GDE No. 552, dated 11.01.2024, and CC No. 110/2024, Dtd: 11.01.2024.

At about 22:20 hrs. I along with my Police Team of Bagmundi PS reached at Banshitanr More and after a while, the police team from district head quarter comprising of 05 (Five) officers and 20 (Twenty) force equipped with sophisticated weapons, under the leadership of Superintendent of Police, Purulia arrived there. After that, as per kind order of Superintendent of Police, Purulia, all force and officer of both the team fell-in for briefing and then proceeded towards the Chounia jangle patch (target place) in cross country movement maintaining all SOP of jungle operation. After almost one and half hours, we reached the target place and planned an ambush at the probable area to intercept the subject as per source information. After some time we observed a person approaching towards to jungle using footmarks from the opposite side. We had previous information that the subject is equipped with sophisticated fire arms loaded with ammunitions. Accordingly he was allowed to come inside our ambush point and then without any delay we intercepted him from the backside with utmost caution, allowing him no chance to escape or to use the fire arms. We immediately took out his bag from his back. At that very moment that intercepted person started slogans "Maobad Jindabad... Jhuta Swadhinata Murdabad... Rastra Shakti Nipat Jaak..." in Bengali repeatedly. On search we found a sophisticated small fire arms loaded with ammunition from the said bag along with some documents in the form of magazine, pamphlets and leaflets and others articles including some cash as mentioned above.

On asking, the intercepted person disclosed his identity as Sabyasachi Goswami @ Kishore @ Ajoy Da @ Babu, aged about 55 years, Son of Late Subhas Chandra Goswami, of Shaktipur, Agarpara, PS. Khardah, District North 24 Parganas, West Bengal. During interrogation, regarding his whereabouts, and reasons for such movement at that place, he initially made misleading statements, but on being continuous questioning, he confessed the he is the member of the banned organisation CPI (Maoist), he also claimed himself as a Central Committee Member, member of Eastern Regional Bureau and in the charge of the Bengal of the said organisation. He also disclosed that he came here to attend a secret meeting with his counterparts of neighbouring areas with a view to recruit the new cadres at the Jungal Mahal area, to revive the Arms Squad with a view to organise subversive activities against the State and disturbing the peace and tranquillity of the Jungle Mahal. He further disclosed regarding the execution of some secret agendas to send some message to Government by destroying government properties and eliminates some targets. He also admitted his aim of circulation of organisational documents to other members, and to hand over some organisational letters and collected fund (raised through Levy) to some another important counter part of the organisation as per direction.

Accordingly as per kind direction of the superior, I seized the above mentioned articles under proper seizure list between 00:30 hrs. and 02:15 hrs. after maintaining all relevant formalities of Seizure. In the meantime, a section of police team searched the surrounding area maintaining all SOP. After that at 02:25 hrs. I arrested the above noted intercepted person namely Sabyasachi Goswami @ Kishore @ Ajoy Da @ Babu, aged about 55 years, Son of Late Subhas Chandra Goswami, of Shaktipur, Agarpara, PS. Khardah, District North 24 Parganas, West Bengal observing the guidelines of the Hon'ble Apex Court.

At 02:30 hrs. as per direction of the superiors we the police team along with arrested accused person namely Sabyasachi Goswami @ Kishore @ Ajoy Da @ Babu, aged about 55 years, Son of Late Subhas Chandra Goswami, of Shaktipur, Agarpara, PS. Khardah, District North 24 Parganas, West Bengal, and all relevant documents and seized articles, started to proceed towards Banshitanr more maintaining the SOP of jungle operation. At about 04:05 hrs. we all returned back to Banshitnar More and from there as per direction of superior, I along with my Police Team of Bagmundi PS and arrested accused person namely Sabyasachi Goswami @ Kishore @ Ajoy Da @ Babu, aged about 55 years, Son of Late Subhas Chandra Goswami, of Shaktipur, Agarpara, PS. Khardah,

District North 24 Parganas, West Bengal with all relevant documents and seized articles, left for Bagmundi Police Station.

Hence, it appeared from the above fact and circumstances that the above noted accused person named Sabyasachi Goswami @ Kishore @ Ajoy Da @ Babu, aged about 55 years, Son of Late Subhas Chandra Goswami, of Shaktipur, Agarpara, PS. Khardah, District North 24 Parganas, West Bengal, being an active member as well as leader (position holding by him in the banned terrorist organisation CPI(Maoist)) entered into a criminal conspiracy with his other associates for waging war to overthrow the established Govt. of India by armed revolution and pursuant to that conspiracy he procured several Maoist literatures, leaflets, letters, etc and raised and possessed fund for terrorist organisation- CPI(Maoist) and its activity for abetting waging war against the Govt. of India, involved himself in recruiting others to work for the their banned terrorist organisation CPI(Maoist) and also invited support for their organisation and thereby, he along with his other associates has committed offences U/s. 121/121A/122/123/120B IPC and 16/17/18/18B/20/38/39/40 of the U.A.(P) Act read with Section 25/27 Arms Act.

I hereby producing the accused Sabyasachi Goswami @ Kishore @ Ajoy Da @ Babu, aged about 55 years, Son of Late Subhas Chandra Goswami, of Shaktipur, Agarpara, PS. Khardah, District North 24 Parganas, West Bengal, in custody, along with seized accuments and articles, and relevant documents etc. before you for necessary further legal measures.
