Sub: Lodging of F.I.R of theft of Electricity against Rampada Kangsabanik
, S/o Lt. Dibakar Kangsabanik at his Domestic premises at Vill.-Saridi,
P.S.-Bagmundi and thereby committed an offence punishable
U/S 135(1)(b) of Electricity Act 2003 amended in 2007.

Dear Sir,

This is to inform you that, I Sri Sisir Kumar Das (35), S/O - Banamali Das, D.E. & Station Manager of Bagmundi, CCC of WBSEDCL received an information to the effect that Rampada Kangsabanik, S/o Lt. Dibakar Kangsabanik residing at Vill.- Saridi was committing theft of Electricity at his Domestic premises by bypassing the proper registration of units by tampering the Service cable of the Energy meter.

Acting on this information this day 17.01.2024, I alongwith Sri Partha Chakraborty, D.E.(S & LP) of Purulia Region Office, Sri Promod Ranjan Barman, S.O. of Purulia Region S & LP Unit, Sri Dayamay Mahato, Sr. TSH of Purulia Region S & LP Unit had been to the house of Rampada Kangsabanik at the above mentioned address. He was present at his house. We contacted him and disclosed our identity to him. On being asked he allowed us to inspect the Energy meter & Service cable of WBSEDCL installed at his domestic premises against the name of the consumer namely Rampada Kangsabanik.

Also search for local people as witnesses during our inspection of the Energy meter of the said premises but none came forward though some local people gathered there. The premises was a one storied building and the meter is installed at the entrance of that premises. Immediately, a notice was prepared duly signed by him served upon him and held inspection.

During inspection, it was detected that, Rampada Kangsabanik had tampered the service cable of the energy meter installed at Domestic premises bearing meter No: T2070365 in the name of Rampada Kangsabanik at the said premises to bypass the proper registration of units by tampering the service cable to commit theft of Electricity. Inspection also revealed that Rampada Kangsabanik was the actual user of the above mentioned service connection.

Immediately, on my direction Sri Dayamay Mahato, Sr. TSH of Purulia Region S & LP Unit disconnected the above mentioned service connection after securing the installation place from any imminent danger in future. Rampada Kangsabanik was shown the tampered service cable but being asked he could not render any satisfactory explanation. He was informed about the offence committed by him and its penal provision.

Sri Partha Chakraborty, D.E.(E) of Purulia Region Office prepared inspection report in his presence and witnesses at the spot and load assessed as 1.2KW. The details of inspection has been mentioned in the inspection sheet attached herewith.

From the evidence so far collected from the inspection of the service cable of Rampada Kangsabanik, it is well established that Rampada Kangsabanik was consuming Electricity illegally in his Domestic residence and for this activity of theft the WBSEDCL has incurred huge loss of revenue.

Sri Partha Chakraborty, D.E.(E) of Purulia Region Office prepared Seizure list in respect of the said premises in presence of the consumer and witnesses at the spot.

The inspection was held between 11:50AM to 12:10PM today after observing all legal formalities.

It is well evident that accused Rampada Kangsabanik, S/o Lt. Dibakar Kangsabanik of Vill.- Saridi has committed offence punishable U/S 135(1)(b) of Electricity Act 2003 amended in 2007.

You are requested to take cognizance of this complain & treat it as FIR
