In producing herewith arrested accused Lakshman Chandra Das @ Gobla (39 yrs) S/O-Sushil Das of Vill-Junbani, PS-Raipur, Dist-Bankura Pin-721504, and brought under seizure 1) One improvised fire arms designed as 7.62 mm pistol having firing pin, hammer, trigger, iron made body barrel and one magazine loaded with 03 rounds cartridges and 2) one blue & black colour Honda SP125 Motorcycle bearing Reg No- WB 68A 6806 under proper seizure list duly signed by the witnesses as well as accused person.

I like to report that today (13.01.2024) at 10:15 Hrs. myself received an information to the effect that one young man coming Balarampur by riding Motorcycle through Chakuliya road and posses a fire arms with some ill motives. This matter noted in general diary vide Balarampur PS GD entry No.- 558. Dtd- 13.01.2024.

Accordingly, myself along with C/2989 Prasenjit Das and C/2312 Rajendranath Bera of Balarampur PS with hired vehicle left for Chakuliya road (Jharkand border) to work out the information.

Around 10:45 hrs. we reached outside of Chakuliya village on Chakuliya road and waited. After sometime we noticed that one young man was coming from Berada towards Chakuliya village. We detained the person and disclosed our identity and asked him we have an information that he posses illegal fire arms and we wants to search his persons. Further asked him if he want he may search our persons before search his persons but he declined.

The area was totally lonely, I did not find any disinterested person or passerby on that time on that spot. So, I made my accompinian force C/2989 Prasenjit Das and C/2312 Rajendranath Bera of Balarampur PS as witness of search and seizure. During search I recovered one improvised fire arms designed as 7.62 mm pistol having firing pin, hammer, trigger, iron made body barrel and one magazine loaded with 03 rounds cartridges from his left waist. On asked he failed to produce any valid documents to posses the fire arms.

Then I seized 1) One improvised fire arms designed as 7.62 mm pistol having firing pin, hammer, trigger, iron made body barrel and one magazine 2) 03 rounds cartridges (loaded within serial No- 1) 3) 01 blue & black colour Honda SP125 Motorcycle bearing Reg No- WB 68A 6806 under proper seizure list dully signed by the witnesses C/2989 Prasenjit Das and C/2312 Rajendranath Bera of Balarampur PS. The search and seizure were made by me in between 11:15 hrs. to 11:35 hrs. A copy of seizure list handed over to Lakshman Chandra Das @ Gobla and as token took his signature on seizure list also prepare label and said Lakshman Chandra Das @ Gobla (39 yrs) S/O-Sushil Das of Vill-Junbani, PS-Raipur, Dist-Bankura Pin-721504 taken into custody as he is liable to prosecute under section 25(i)(a)/27 Arms Act.

Accordingly, I started the case suo moto against Lakshman Chandra Das @ Gobla (39 yrs) S/O-Sushil Das of Vill-Junbani, PS-Raipur, Dist-Bankura Pin-721504 u/s 25(i)(a)/27 Arms Act.

SI Sanjay Banerjee of Balarampur PS will investigate the case
