Dear Sir,

I do hereby lodge complaint empowered by the Electricity Act 2003, Amendment of 2007 to the effect that, the below mentioned accused has committed interference with meter or work of licensee U/S 138 1/b of the electricity Act 2003, Amendment of 2007 as stated here under.

Today i.e, on 18.01.2024 I, Sri Sisir Kumar Das, S/O- Sri Banamali Das, DE & SM along with Sri Manab Kr. Maji, J.E.(E) Gr-II, Sri Arindam Chatterjee, Sr. O.E, Balarampur CCC and technical persons of M/s. Niharika Electric Works (Enlisted Agency of WBSEDCL) went to make an inspection to workout upon a source information regarding unauthorized reconnection of a service connection bearing consumer id no 202535616 in the name of Churamani Tudu Village of Purnapani, P.O:- Rangadih, P.S:- Balarampur, Dist- Purulia. The service connection was disconnected by WBSEDCL on 04.07.2018 due to non-payment of outstanding bill. The outstanding is Rs 3707.91/- excluding applicable late payment surcharge as per regulation. The service connection is in deemed disconnected status in our database.

During the time of inspection at the domestic premises 1 no of electricity meter was found having Meter SI No:- HR041329 bearing Consumer id 202535616, Consumer Name- Churamani Tudu. The meter was connected to the mains through a service cable. The user Samay Tudu was enjoying electricity service and the reading on the meter was recorded 3250 KWH .

In presence of the inspection team at about 12.10 P.M. entered to the premises and observed that user Samay Tudu was using electricity whimsically re-connecting the service line bearing consumer id no 202535616 and has made offence under section 138 1/b. Accused has made huge financial loss to WBSEDCL.

After detection of unauthorized reconnection of service line illegally and dishonestly, the inspection team disconnected the service line in the premises from pole with the help of LT Mobile Van Team.

The inspection team left the premises at about 12.30 P.M.

The accused Samay Tudu S/O Lt. Shikar Tudu of Vill - Purnapani, P.O:- Rangadih, P.S.-Balarampur has committed interference with meter or work of licensee under section 138 1/b of the electricity Act 2003, Amendment of 2007.

I prepared seizure list in presence of witnesses, details of seizure have been mentioned in the seizure list duly signed by the Accused. A copy of the seizure list was handed over to the accused. The Local people gathered there witnessed the incident but refused to sign on the Seizure list and inspection report.

You are requested to take cognizance of the complaint & treat this as FIR and take necessary action.
