Dear Sir,

I do hereby lodge complaint empowered by enabling The Indian Electricity Act – 2003, subsequently Electricity (Amendment) Act 2007 to the effect that Suku Murmu, S/o – Takra Murmu, resident of Vill – Koardi, kuchia, PS – Bundwan, Dist – Purulia has committed theft of electricity U/S 138/1/b of The Electricity Act.

On 19/01/2024 about 12:18 hrs, I, Prashanta Mandal, AE&SM, Bundwan CCC, WBSEDCL, along with Sri Maruti Mahato, JE (E) – Gr – I, Bundwan CCC, WBSEDCL, Majam Ali Ansari, HG TSH, Bundwan CCC and Shubhankar Majumder, Sr. TSH Bundwan CCC, WBSEDCL visited the premises of Suku Murmu, S/o – Takra Murmu, Vill- Koardi, kuchia, PS – Bundwan, Dist – Purulia and inspect his premises. During inspection theft of electricity was detected i.e. he was using electricity unauthorizedly by means of reconnecting meter with LTOH line while his electric connection was deemed disconnected since 28/08/2017.

From the above arrangement he was using the following electrical equipment's:

- 1) Bulb – 4 nos, 2) Fan – 1 Nos

Out of which I seized the following:

- 1) Service cable black (approx. 12 mtr).

Seizure list was prepared at the site and accused person refused to sign. The inspection team left the premises at 13:05 hrs on 19/01/2024. The accused person has committed an offence U/S 138/1/b of The Electricity Act – 2003 & subsequently Electricity (Amendment) Act – 2007.

You are requested to take cognizance of this complaint and treat it as F.I.R. and action may be taken as per rule.
