Sub: Prayer to start a specific case under proper section of law.

Sir,

In producing herewith 03 (Three) arrested accused persons namely (i) Abu Bakkar Ansary @ Kalu Ansary (50 Yrs) S/o- Lt. Latib Ansary of Rasuldih PS-Balarampur, Dist-Purulia (ii) Niyaz Ahmed @ Vicky Ahmed (29 Yrs) S/o- Lt. Muktar Ahmed of Balarampur (Registrypara) PS-Balarampur, Dist-Purulia and (iii) Abhijit Chakraborty (26 Yrs) S/o- Chinmoy Chakraborty of Balarammpur (Stationpara) PS-Balarampur, Dist-Purulia along with seized articles- (i) One "Improvised Iron made one shotter pipe gun" seized from the exclusive possession of Niyaz Ahmed @ Vicky Ahmed S/o- Lt. Muktar Ahmed of Balarampur (Registrypara) PS-Balarampur (ii) One Hero Scooty having Registration No- WB56-L/6970 seized from the possession of Do (iii) One Iron made "Vojali" seized from the possession of Abu Bakkar Ansary @ Kalu Ansary S/o- Lt. Latib Ansary Vill-Rasaldih, PS-Balarampur, Dist-Purulia (iv) One Iron Rod having length- 3.5 ft seized from the possession of Abhijit Chakraborty S/o- Chinmoy Chakraborty Vill-Balrampur, (Station Para) PS-Balarampur, Dist-Purulia.(v) One live ammution which has been fitted at one shatter pipe gun.

I beg to lodge a complaint to the effect that on 29.01.2024 duty officer received a source information that some unknown miscreants are assembled Sindri Rammandir ground and preparing themselves to commit road dacoity for extorting money from businessman on lonely pitch road in between Laka to Sindri under Barabazar PS. Duty officer informed the matter to I.C Barabazar PS. Accordingly, I.C Barabazar PS briefed us and directed us to work out the said source information with additional officers and force. The fact noted in GD, this refers to Barabazar PS GDE No- 1921 Dtd. 29.01.2024. Myself along with ASI Jaydip Mukherjee, ASI Sudip Mardana, C/-1481 Gadadhar Biswas, C/- 3218 Sukchand Mandi, C/- 2671 Prasanta Rajak, C/- 2793 Tushar Kanti Roy and NVF/-648 Debdas Modak left PS to work out the information as per direction of I.C Barabazar PS. This refers to Barabazar PS GDE No- 1923 Dtd. 29.01.2024 and C.C No- 345/2024 Dtd. 29.01.2024. We carry sufficient light, kit box, papers, carbon gala, etc.

Myself along with force reached nearby Sindri Chawkbazar and stop the vehicle by the side of Road keeping distance approx 200 meters from Sindri Rammandir. After that, we started to proceed towards Sindri Rammandir Ground on foot. At about 19.55 hrs when we reached near that place, we found 05/06 persons sitting beside the Ground near Sindri Rammandir and whispering to each other. Their voice was clearly audible to us due to evening time & the place was a silent zone. They were planning to commit road dacoity for extorting money from businessman on lonely pitch road in between Laka to Sindri under Barabazar PS. After confirmation, we cordoned the area secretly and loudly disclosed our identity with a direction to surrender before us. But, all of them tried to run away seeing the Police party. However, we manage to apprehend 03 (Three) out of them after a hot chase. I interrogate them thoroughly where they disclosed their identity as (i) Abu Bakkar Ansary @ Kalu Ansary (50 Yrs) S/o- Lt. Latib Ansary of Rasuldih PS-Balarampur, Dist-Purulia (ii) Niyaz Ahmed @ Vicky Ahmed (29 Yrs) S/o- Lt. Muktar Ahmed of Balarammpur (Registry para) PS-Balarampur, Dist-Purulia and (iii) Abhijit Chakraborty (26 Yrs) S/o- Chinmoy Chakraborty of Balarammpur (Statition para) PS-Balarampur, Dist-Purulia. During interrogation they disclosed that they along with 2 others being armed with deadly weapons were gathered and preparing themselves for committing road dacoity for extorting money from businessman on lonely pitch road in between Laka to Sindri under Barabazar PS. Accordingly, I arrested them after maintaining all formalities regarding arrest and issuing Check Lists. Informed them the grounds of arrest and informed relatives. On search, we seized the above noted articles under proper seizure list & Labels duly signed by the witnesses and arrested persons. The seizure was made between 20.25 hrs and 20.50 hrs.

Hence, I do here by lodged complaint against (i) Abu Bakkar Ansary @ Kalu Ansary (50 Yrs) S/o- Lt. Latib Ansary of Rasuldih PS-Balarampur, Dist-Purulia (ii) Niyaz Ahmed @ Vicky Ahmed (29 Yrs) S/o- Lt. Muktar Ahmed of Balarammpur (Registry para) PS-Balarampur, Dist-Purulia and (iii) Abhijit Chakraborty (26 Yrs) S/o- Chinmoy Chakraborty of Balarammpur (Statition para) PS-Balarampur, Dist-Purulia and 2 (Two) Unknown miscreants to start a specific case against them under proper section of law.
