Sir,

I do hereby lodge complaint, empowered by enabling "The Electricity Act , 2003 "subsequently electricity act-2007, to the effect that KAILASH MANDI S/O Lt. KALU MANDI VILL –NARAYANPUR , Dist- Purulia was enjoying electricity illegally by by-passing the Single Phase Energy Meter (SI No- 7S0129278) From its incoming Service Cable through 02-Core PVC wire and he has committed theft of electricity U/S 135(1)/b of the electricity (Amendment act-2007).

On 30.01.2024, I Sri Banti Karmakar, A.E.&S.M, BARABAZAR CCC, WBSEDCL along with

- (1) Shibaji Chakraborty, J.E GR II, BARABAZAR CCC, WBSEDCL
- (2) Sanjit Mahato, Sr. T.S.H , BARABAZAR CCC, WBSEDCL
- (3) Along with LT team

At About 1:50 P.M., entered into the premises of KAILASH MANDI S/O Lt. KALU MANDI VILL –NARAYANPUR , Dist- Purulia and inspected his premises .

while doing inspection at the premises that KAILASH MANDI S/O Lt. KALU MANDI VILL –NARAYANPUR in presence of KAILASH MANDI , we found that the accused one was using electricity by means of by passing the meter consumption with the help of cutting the service cable having specification of Aluminium 2 core 4 square mm and joining an extra cable for black & red mixture in color giving power to his premises at VILL –NARAYANPUR having connected load 0.31 KVA.

Seizure list was prepared at site. After process of inspection and seizure list we left the premises at about 2:10 P.M.

The said person has committed an offence U/S 135(1)/(b) of electricity act 2003 subsequently electricity (Amendment) act-2007.

You are requested to take cognizance of this complaint and treat it as F.I.R and action may be taken as per rule.
