I do hereby lodge complaint empowered by enabling The Indian Electricity Act – 2003, subsequently Electricity (Amendment) Act 2007 to the effect that Purnima Mandi, W/o – Gurupada Mandi, resident of Vill – Golapara (kuiltar), PS – Boro, Dist – Purulia has committed theft of electricity U/S 135/1/a of The Electricity Act.

On 05/01/2024 about 15:50 hrs, I, Prashanta Mandal, AE&SM, Bundwan CCC, WBSEDCL, along with Sri Maruti Mahato, JE (E) – Gr – I, Bundwan CCC, WBSEDCL, Majam Ali Ansari, HG TSH, Bundwan CCC and Shubhankar Majumder, Sr. TSH Bundwan CCC, WBSEDCL visited the premises of Gurupada Mandi, S/o – Ramdas Mandi, Vill- Golapara (kuiltar), PS – Boro, Dist – Purulia and inspect his premises. During inspection theft of electricity was detected i.e. he was using electricity dishonestly by means of DIRECT HOOKING from nearest LTOH line.

From the above arrangement he was using the following electrical equipment's:

- 1) Bulb – 2 nos

Out of which I seized the following:

- 1) Blue color flexible wire (approx. 10 mtr) with hooking device and switch board.

Seizure list was prepared at the site and accused person has signed.

The inspection team left the premises at 16:35 hrs on 05/01/2024.

The accused person has committed an offence U/S 135/1/a of The Electricity Act – 2003 & subsequently Electricity (Amendment) Act – 2007.

You are requested to take cognizance of this complaint and treat it as F.I.R. and action may be taken as per rule.
