Dear Sir,

I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Shakuntala Majhi, W/O-Sujan Majhi of Village- Bhutadih, P.O- Sindraidih, P.S.- Boro, Dist - Purulia, has committed theft of Electricity U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

On dated 08.01.2024 at about 01.30 pm I, Sri Swarup Mandal, Station Manager, Manbazar Customer Care Centre, WBSEDCL along with,

- 1) Sri Sourav Mukherjee, Senior TSH, Manbazar CCC, WBSEDCL
- 2) Sri Gopinath Mahato, Senior TSH, Manbazar CCC, WBSEDCL

entered the premises of Shakuntala Majhi, W/O-Sujan Majhi of Village- Bhutadih, P.O- Sindraidih, P.S.- Boro, Dist - Purulia and inspected her premises and found that she was using electricity unauthorisely by direct hooking from LTOH line of WBSEDCL.

During inspection, theft of electricity was found, i.e., she was using electricity dishonestly U/S 135(1)(a) was detected. It was also found that she was using the following electrical equipments -

- 1) One no incandescent lamp of wattage 100 watt.
- 2) One no table fan of wattage 60 watt.
- 3) One nos tube light of wattage 40 watt.

out of which we seized the following -

- 1) Single core flexible wire of length about 10 meter with hooking device.

The seizure list is prepared at the site and the accused person refused to sign in the seizure list. The inspection team left the above premises at about 01.45 pm on dated 08.01.2024. The accused person has committed an offence U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

You are requested to take cognizance of the complaint and treat it as F.I.R. and action may be taken as per rule.
