Respected Sir,

In producing herewith the following seized one Motor cycle having bearing no - WB 56Q-3376 loaded with Electric aluminum wire (approx) 25 Kg. and accused Pradip Karmakar, Karmakar of village Harialmari P.S. Boro, Dist- Purulia do hereby lodge complaint to the effect that today (18/01/24) at 00.35 hrs, in course of my night mobile duty myself along with C/1119 Susanta Kr. Sinha and C/2695 Sanjoy Kr. Gulimajhi vide Boro PS CC No. 181/24 dt 17.01.24 were performing mobile at Ankro village side under Boro P.S. and found that one Motor cycle having bearing no -WB 56Q-3376 proceeding towards Misri Bandh near Ankro more in a suspicious manner. Accordingly I detained the Motor cycle by giving signal and found that the Motor cycle loaded with Electric aluminum wire. As such I demanded to produce the papers in respect of the Motor cycle as well as loaded with Electric aluminum wire, but he failed to provide any paper either in respect of Motor cycle or loaded with Electric aluminum wire. On further demand he disclosed his name and identity as noted above and made different statement at a different intervals about the procurement of loaded with Electric aluminum wire as why suspicion goes into extreme and it could reasonably be presumed that the above noted accused person procured the Motor cycle and loaded with Electric aluminum wire either by theft or any fraudulent means. So, I seized the Motor cycle having bearing No.WB 56Q-3376 loaded with Electric aluminum wire under proper seizure list duly signed by the accused person as well as police witnesses as no public turned up to stand as witness. Thereafter, I arrested the above noted accused person after observing all legal formalities by issuing copies of seizure list.

So I pray a specific case may kindly be started against accused person Pradip Karmakar, S/O- Dubraj Karmakar of village Harialmari P.S. Boro, Dist- Purulia under proper section of law and arrange for its investigation.
